The format of each bibliographic entry depends on the type of source being cited. For books, this typically includes the author's name, the title of the book (*italicized*), the place of publication, the publisher, and the year of publication. For articles, it will include the author, article title, journal title (*italicized*), volume and issue numbers, and the page range. Citing Books: Monographs and Edited Collections

"The Future of Renewable Energy." *Modern Science Monthly*, October 15. The focus remains on providing enough information for the reader to locate the specific article.

Citing Online Sources: Websites, Blogs, and Digital Media

The proliferation of online resources necessitates clear guidelines for citing digital content. When citing a webpage, the bibliography entry typically includes the author (if known), the title of the specific page or

article (in quotation marks), the website name (in italics), and the URL. It is also critical to include the date you accessed the page, as online content can change frequently. For example: Garcia, Maria. 2023. "Understanding Digital Citation." *Academic Writing Blog*. Accessed May 10, 2024. <https://www.example.com/writing/digitalcitation>.

For sources like online journals or articles that are only available online, the citation will blend elements of both print articles and web pages. You will include author, article title, journal title, volume, issue, and page numbers if available, but then also the website name (if applicable) and the URL, along with the access date. The primary goal is to ensure the reader can find the exact digital resource you consulted.

Advanced Chicago Author-Date Citation Scenarios

Handling Multiple Authors and Corporate Authors

When a source has multiple authors, the Chicago author-date system has specific conventions for both in-text citations and the bibliography. For works with two or three authors, all authors' names are included in the in-text citation. For the bibliography, the first author's name is inverted, and subsequent authors are listed in normal order. For works with more than three authors, the in-text citation lists only the first author's last name followed by "et al." and the year (e.g., Brown et al. 2019). Corporate authors, such as organizations or government agencies, are cited using the name of the organization as the author. The in-text citation would look like (World Health Organization 2020). The bibliography entry would also use the full name of the organization as the author.

Citing Unpublished Works and Other Materials

Citing unpublished materials, such as dissertations, theses, or manuscripts, requires careful attention to detail. In the bibliography, you would typically include the author's name, the title of the work (in italics), the type of document (e.g., Ph.D. dissertation, manuscript), the institution that awarded the degree or the archive where it is housed, and the year. For example: Lee, Sarah. *The Evolution of Language*. Ph.D. dissertation, University of California, Berkeley, 2018. The in-text citation would follow the standard author-date format.

Other materials like interviews, lectures, or personal communications are also handled. Personal

communications (letters, emails) are generally not included in the bibliography as they are not retrievable by the reader. They are cited in-text only, with the name of the communicator, the date, and the medium (e.g., (Jane Doe, personal communication, May 1, 2023)). Interviews, if published or archived, are cited like other published works; if conducted personally and unpublished, they may be cited in-text similarly to personal communications.
