Understanding Chicago Style Citation for Direct Quotes

The Chicago Manual of Style (CMOS) offers two primary citation systems: the Notes-Bibliography system and the Author-Date system. Both are widely accepted in academic circles, but their application to direct quotes differs in placement and format. The Notes-Bibliography system uses footnotes or endnotes for in-text citations, while the Author-Date system uses parenthetical citations within the text. Regardless of the system chosen, the fundamental goal remains the same: to accurately acknowledge the source of every direct quotation used. This acknowledgment not only prevents plagiarism but also allows readers to locate the original source for further research or verification.

Selecting the appropriate Chicago citation system often depends on the specific academic discipline or publisher's requirements. Humanities disciplines, such as literature and history, commonly favor the Notes-Bibliography system, which allows for more extensive explanatory notes. Conversely, social sciences and natural sciences often prefer the Author-Date system for its conciseness and ease of integration into the text. This article

The Notes-Bibliography System: Direct Quote Examples

In the Notes-Bibliography system, direct quotes are acknowledged through numbered footnotes or endnotes. The first time a source is cited, the note contains full bibliographic information. Subsequent citations of the same source become shortened. This system is particularly useful for incorporating supplementary information or commentary without disrupting the flow of the main text.

Footnote and Endnote Structure for Direct Quotes

When citing a direct quote using the Notes-Bibliography system, the footnote or endnote will typically include the author's first and last name, the title of the work, publication details, and the specific page number(s) where the quote can be found. For subsequent citations, a shortened form is used, generally including the author's last name, a shortened title, and the page number. Example of a Subsequent Note for a Book Quote

If you cite another quote from the same book on page 78, the subsequent note would be shortened:

- 2. Smith, *Art of Writing*, 78.

Example of a Note for a Journal Article Quote

For a direct quote from a journal article, the note would include the author, article title, journal title, volume and issue numbers, publication year, and page number. For instance, quoting Sarah Lee from page 112 of her article "Academic Discourse" in Volume 30, Issue 2 of the *Journal of Scholarship* (2021):

- 3. Sarah Lee, "Academic Discourse," *Journal of Scholarship* 30, no. 2 (2021): 112.

Example of a Note for a Website Quote

Citing a direct quote from a website requires the author (if available), the page title, the website name, and the URL. If a specific date of publication is available, it should be included. For example, a quote from an article on the National History Society website, authored by Mark Brown, titled "Preserving the Past," accessed on October 26, 2023:

- 4. Mark Brown, "Preserving the Past," National History Society, accessed October 26, 2023, <https://www.nationalhistory.org/preserving-the-past>.

The Author-Date System: Direct Quote Examples

The Author-Date system employs parenthetical citations directly within the text, typically appearing at the end of the sentence containing the quote. These citations usually include the author's last name, the year of publication, and the page number. A corresponding bibliography at the end of the document provides the full bibliographic details for each source cited.

Parenthetical Citation Structure for Direct Quotes

The standard format for a parenthetical citation in the Author-Date system is (Author Last Name Year, Page Number). This concise format allows readers to quickly identify the source and locate it in the reference list without interrupting the reading flow significantly.

Example of a Parenthetical Citation for a Book Quote

Using the same example of John Smith's "The Art of Writing," a direct quote from page 45

would be cited parenthetically as follows:

"The nuances of language require careful attention to detail," Smith wrote (Smith 2022, 45).

Example of a Parenthetical Citation for a Journal Article Quote

For Sarah Lee's article, a quote from page 112 would be cited like this:

The concept of academic discourse is complex (Lee 2021, 112).

Example of a Parenthetical Citation for a Website Quote

Citing a quote from the National History Society website, authored by Mark Brown, would follow this format:

"Our collective memory is a vital resource," stated Brown (Brown 2023).

Note: If the website does not have a publication date, you may omit the year, but ensure the author and title are clear in your reference list.

Formatting Direct Quotes in Text

The way a direct quote is integrated into your text depends on its length. Chicago style differentiates between short quotations (generally fewer than five lines of prose or fewer than three lines of poetry) and long quotations. Proper formatting ensures that the quote is clearly distinguishable from your own writing and adheres to academic standards.

Short Quotations

Short quotations are typically enclosed in double quotation marks and integrated directly into your sentence. The citation follows immediately after the closing quotation mark, before the sentence's punctuation.

Example of a Short Quotation Integration

According to the report, the economic impact was "significant and widespread" (Johnson 2023, 15).

Long Quotations (Block Quotes)

Long quotations (five lines or more of prose) are set off from the main text as a block quote. This means they are indented from the left margin, without quotation marks. The citation typically follows the final punctuation of the block quote.

Example of a Block Quote Integration

The author elaborates on the challenges of implementing new policies:

The implementation of these directives presented unforeseen logistical hurdles. Resistance from various stakeholders, coupled with a lack of adequate training, slowed progress considerably. It became evident that a more phased approach, with greater emphasis on stakeholder engagement, would have been more effective in achieving the desired outcomes.

Citing Direct Quotes from Books

Books remain a primary source for many academic endeavors, and citing direct quotes from them requires precision. Whether using the Notes-Bibliography or Author-Date system, the core information needed is the author, title, publication details, and page number. The specific format of the citation will, of course, vary between the two systems.

Notes-Bibliography System for Book Quotes

As detailed earlier, the Notes-Bibliography system uses footnotes or endnotes. The first citation for a book includes all necessary details, while subsequent citations are shortened. This ensures the reader can always trace the quote back to its origin.

Author-Date System for Book Quotes

The Author-Date system uses in-text parenthetical citations, which are concise and include the author's last name, publication year, and page number. The full bibliographic details are provided in a reference list at the end of the document.

Citing Direct Quotes from Journal Articles

Journal articles are another vital source in academic research. Citing direct quotes from

them follows similar principles to citing books, with the inclusion of article-specific details such as the journal title, volume, issue number, and date.

Notes-Bibliography System for Journal Article Quotes

In the Notes-Bibliography system, footnotes or endnotes for journal articles will include the author's name, the article title in quotation marks, the journal title in italics, volume and issue numbers, publication year, and the specific page number(s).

Author-Date System for Journal Article Quotes

The Author-Date system will use parenthetical citations within the text, typically (Author Last Name Year, Page Number), with the full details in the reference list.

Citing Direct Quotes from Websites

The digital age has made websites an indispensable source of information. However, citing them can sometimes be more complex due to varying levels of information provided (e.g., missing publication dates or authors). Chicago style provides guidelines for these situations.

Notes-Bibliography System for Website Quotes

When citing a website, include as much information as is available: author (if applicable), title of the specific page or article, the name of the website, and the URL. The date of access is often included, especially if the content is likely to change.

Author-Date System for Website Quotes

For the Author-Date system, parenthetical citations for websites will generally include the author's last name and, if available, the year of publication. If no author is listed, the title of the page or article may be used, or a shortened version of it. The URL and access date will be in the reference list.

Special Considerations for Direct Quotes

Ellipses for Omitted Text

Brackets for Added or Modified Text

Brackets are used to insert clarifying words, phrases, or explanations into a quotation. This is essential when you need to ensure the quote makes sense within the context of your own writing, or if you need to correct a minor error in the original text (though this should be done sparingly).

- Example: She stated, "The process [of revision] was more arduous than anticipated."

Quotations within Quotations

When quoting someone who is themselves quoting another source, use single quotation marks for the inner quotation and double quotation marks for the outer quotation in the Notes-Bibliography system. In the Author-Date system, the structure remains the same within the text, but the citation will refer to the primary source you are referencing.

Common Pitfalls in Citing Direct Quotes

A: For online encyclopedias or dictionaries, cite the author if available. If no author is listed, use the title of the entry. Include the name of the encyclopedia or dictionary and the URL. In the Notes-Bibliography system, you would also include an access date. In the Author-Date system, you would use the year of publication if available, or the access date if no publication year is present.

Q: Is it acceptable to modify a direct quote for clarity or flow?

A: Yes, it is acceptable to modify a direct quote using ellipses to indicate omitted text or brackets to add clarifying words or phrases. However, these modifications should never alter the original meaning of the quote. Major alterations should be avoided, and if significant changes are needed, paraphrasing is usually a better option.
