Identifying the edition statement within a book is usually straightforward. The information is almost invariably found on the title page or the verso of the title page (the page immediately following the title page, often containing copyright information). In contrast, a "new printing" or "reprint" usually refers to producing more copies of an existing edition without altering the content. Therefore, meticulously checking the title page and copyright page for explicit indications of revision or edition change is paramount before including this detail in your citations.

Chicago Citation Examples: Notes–Bibliography System

The Notes-Bibliography system is commonly used in the humanities. When citing a book with edition information, the edition statement is typically placed after the author's name and before the publication details. Citing Specific Types of Editions

Beyond standard numbered or revised editions, Chicago style provides guidance for more specialized cases, ensuring accuracy and completeness in your citations.

Revised and Expanded Editions

When a book has been both revised and expanded, it's important to note both aspects if they are

indicated on the title page. The Chicago Manual of Style often uses abbreviations like "rev. and enl."

- Notes-Bibliography Example:
- Author Name, *Book Title*, rev. and enl. ed. (Place of Publication: Publisher, Year), page number.
- Author-Date Example:
- Author Last Name, Author First Name. Year. *Book Title*. Rev. and enl. ed. Place of Publication: Publisher.

Annotated Editions

Annotated editions, often found with literary classics or scholarly works, include substantial commentary or notes from an editor or annotator. The annotator should be treated similarly to an editor in the citation.

- Notes-Bibliography Example:
- Author of Original Work, *Book Title*, annotated by Annotator Name, edition information (Place of Publication: Publisher, Year), page number.
- Author-Date Example:
- Author Last Name, Author First Name. Year. *Book Title*. Annotated by Annotator First Name Annotator Last Name. edition information. Place of Publication: Publisher.

Facsimile Editions

A facsimile edition is a reproduction of an older edition. When citing such a work, it's important to include information about both the original publication and the facsimile edition.

- Original Author Name, *Original Book Title* (Original Publication Year; Original Place of Publication: Original Publisher), facsimile ed. (Facsimile Edition Place of Publication: Facsimile Edition Publisher, Facsimile Edition Year).
- Author-Date Example:
- Original Author Last Name, Original Author First Name. Original Publication Year. *Original Book Title*. Original Place of Publication: Original Publisher. Facsimile ed. Facsimile Edition Place of Publication: Facsimile Edition Publisher, Facsimile Edition Year.

Common Pitfalls in Citing Edition Information

Despite clear guidelines, writers often make mistakes when incorporating edition information into their Chicago-style citations. One of the most frequent errors is neglecting to include the edition statement at all when it is other than the first edition. This oversight can lead to the confusion mentioned earlier.
