Example of a subsequent citation:

2. Smith, "Local Council Debates," 5.

Example when the author is already established:

3. "City Gears Up," B2.

Citing Articles with No Author or Bylines

In cases where a newspaper article lacks a byline or a clear author, the citation begins with the article title. This ensures that the reader can still identify the specific piece of writing. The title should be enclosed in quotation marks, followed by the newspaper name, date, and page number.

Handling Multiple Authors

If an article has two or three authors, all their names should be included in the footnote/endnote. For four or more authors, list the first author's name followed by "et al." in the footnote/endnote.
