Understanding the Basics of Chicago Style Citations

The Chicago Manual of Style offers two primary citation systems: the notes-bibliography system and the author-date system. Both systems aim to provide readers with clear and consistent information about the sources used in a work. - First Author Last Name et al., *Shortened Title* (or just the page number if the title is obvious and the full citation has already appeared), Page Number.

For instance, if the above book was cited again:

5. Smith et al., *History of Ideas*, 112.

Or, if the context makes it clear:

7. Smith et al., 150.

The Reference List

The reference list, or bibliography, presents a complete list of all sources consulted. For works with three or more authors, the Chicago Manual of Style dictates that all authors' names should be included in the entry. This provides a thorough accounting of all contributors for the reader examining the full list of sources.

The format for a book with three or more authors in the reference list is:

- Last Name, First Name, First Name Last Name, and First Name Last Name.
Title of Book. Place of Publication: Publisher, Year.

Following the previous example, the reference list entry would be:

Smith, John, Jane Doe, and Robert Johnson. *The History of Ideas*. Chicago: University of Chicago Press, 2020.

It is important to note that the reversal of the first author's name (Last Name, First Name) is standard for the reference list, while subsequent authors are listed in their normal first-name-last-name order. This convention helps distinguish the primary author and aids in alphabetical sorting.

Author-Date System for Three or More Authors

The author-date system, prevalent in the social sciences and natural sciences, uses parenthetical in-text citations and a reference list. Similar to the notes-bibliography system, Chicago style provides specific guidelines for handling multiple authors to maintain conciseness and clarity.

When citing multiple sources in a single parenthetical, the citations are generally separated by semicolons:

(Smith et al. 2020; Doe and Johnson 2019).

The Reference List

The reference list in the author-date system is similar to the bibliography in the notes-bibliography system in that it includes all authors' names for works with three or more authors. The primary difference lies in the placement of the publication year, which immediately follows the author(s) in the reference list entry.

The format for a book with three or more authors in the author-date reference list is:

- Last Name, First Name, First Name Last Name, and First Name Last Name. Year. *Title of Book*. Place of Publication: Publisher.

The reference list entry would be:

Smith, John, Jane Doe, and Robert Johnson. 2020. *The History of Ideas*. Chicago: University of Chicago Press.

As with the notes-bibliography system, the first author's name is reversed. This consistency ensures that readers can easily locate the full bibliographic information for any cited source.
