The Notes and Bibliography System Explained

The Author-Date System in Practice

The Author-Date system, another prominent variant of Chicago style, is widely employed in the social sciences and natural sciences. This system relies on brief in-text citations, typically including the author's last name and the publication year, followed by a page number if necessary. These parenthetical citations directly correspond to a full Reference List at the end of the paper, which alphabetically lists all sources cited. This method offers a concise way to acknowledge sources within the text, streamlining the reading experience for those accustomed to this format.

In-Text Citations in Author-Date

When using the Author-Date system, an in-text citation typically appears in parentheses within the sentence or at the end of it. For instance, a citation might look like (Smith 2020, 45). This brevity allows the narrative flow to remain largely uninterrupted. If the author's name is mentioned in the text, only the year and page number are needed within the parentheses, such as (2020, 45). This dual approach ensures that readers can quickly pinpoint the source of information without disrupting the main body of the text.

Compiling the Reference List

The Reference List in the Author-Date system serves a similar purpose to the bibliography in the Notes and Bibliography system: it provides a complete alphabetical listing of all sources consulted and cited in the paper. Each entry in the Reference List contains full bibliographic details, allowing readers to locate the original work. For subsequent citations, a shortened version is used. The bibliography entry for a book omits the page number of the specific citation but includes all other publication details.

For example, a first note might look like:

A subsequent note for the same book:

The bibliography entry would be:

Books in the Author-Date System

In the Author-Date system, books are cited parenthetically in the text with the author's last name and the year of publication, followed by a page number if needed. The corresponding entry in the Reference List includes the author's full name, the publication year in parentheses, the title of the book (italicized), and publication information.

For example, an in-text citation might be:
(Doe 2022, 75).

The Reference List entry would be:
Doe, Jane. 2022. *The Art of Research*. Chicago: University of Chicago Press.

Citing Journal Articles in Chicago Style

Journal articles are a staple of scholarly research, and Chicago style offers precise methods for their citation to ensure proper attribution and ease of retrieval. These citations typically include details about the authors, article title, journal title, volume and issue numbers, publication year, and page range. Journal Articles in Notes and Bibliography

The bibliography entry:

Smith, John, and Emily Jones. "The Impact of Technology on Education." *Journal of Modern Studies* 45, no. 2 (2021): 123-145.

Journal Articles in Author-Date

In the Author-Date system, an in-text citation for a journal article includes the author's last name(s) and the publication year, potentially with a page number. The Reference List entry provides the author(s)' full name(s), the publication year in parentheses, the article title (in quotation marks), the journal title (italicized), and the volume, issue, and page range.

An in-text citation could be:

(Smith and Jones 2021, 123).

The Reference List entry:

Smith, John, and Emily Jones. 2021. "The Impact of Technology on Education." *Journal of Modern Studies* 45, no. 2 (2021): 123-145.

Citing Websites and Online Resources in Chicago Style

The digital age has expanded the range of sources available to researchers, and Chicago style provides guidance for citing websites and other online materials. In Notes and Bibliography, a newspaper article note might look like:

A magazine article note:

7. David Chen, "The Future of Renewable Energy," Science Today, December 2023, 34.

The corresponding Reference List entries would be:

Lee, Sarah. "Local Elections See High Turnout." Chicago Tribune, November 7, 2023.

Chen, David. "The Future of Renewable Energy." Science Today, December 2023.

Interviews and Personal Communications

Interviews and other forms of personal communication are cited differently because they are not typically published or widely accessible. In the Notes and Bibliography system, these are usually cited in a footnote or endnote, often without a corresponding bibliography entry unless they are recorded and archived.

Example of an interview note:

8. Interview with Dr. Evelyn Reed, March 10, 2023.

In the Author-Date system, personal communications are generally mentioned parenthetically in the text and not included in the Reference List, as they are not retrievable by the reader.

Example of an in-text citation:

(E. Reed, personal communication, March 10, 2023).
