WHEN IS A CHICAGO MANUAL ABSTRACT REQUIRED?

UNDERSTANDING THE PURPOSE OF A CHICAGO MANUAL ABSTRACT FOR PAPER

AN ABSTRACT SERVES AS A MINIATURE VERSION OF YOUR ENTIRE PAPER, OFFERING A CONCISE OVERVIEW TO POTENTIAL READERS. FOR A CHICAGO MANUAL ABSTRACT FOR PAPER, ITS PRIMARY PURPOSE IS TO ALLOW INDIVIDUALS TO QUICKLY ASSESS THE RELEVANCE AND SIGNIFICANCE OF YOUR WORK WITHOUT HAVING TO READ THE ENTIRE DOCUMENT. BEYOND MERE SUMMARIZATION, AN EFFECTIVE ABSTRACT ALSO FUNCTIONS AS A MARKETING TOOL FOR YOUR RESEARCH. IT MUST BE COMPELLING ENOUGH TO PIQUE THE READER'S INTEREST AND PERSUADE THEM TO DELVE DEEPER INTO YOUR FINDINGS. IN MANY DISCIPLINES, ABSTRACTS ARE SEARCHABLE THROUGH DATABASES, MAKING THEM THE FIRST POINT OF CONTACT FOR MANY RESEARCHERS. THEREFORE, A CLEAR, ACCURATE, AND WELL-STRUCTURED ABSTRACT IS PARAMOUNT FOR ENSURING YOUR WORK IS DISCOVERED AND UNDERSTOOD BY THE INTENDED AUDIENCE. ADHERING TO THE CHICAGO MANUAL OF STYLE ENSURES CONSISTENCY AND PROFESSIONALISM IN THIS CRITICAL INTRODUCTORY ELEMENT.

KEY COMPONENTS OF A CHICAGO MANUAL ABSTRACT

METHODOLOGY

A BRIEF DESCRIPTION OF THE METHODS USED TO CONDUCT YOUR RESEARCH IS ESSENTIAL. KEY FINDINGS OR RESULTS

THIS IS ARGUABLY THE MOST IMPORTANT PART OF YOUR ABSTRACT. HERE, YOU PRESENT THE MOST SIGNIFICANT OUTCOMES OF YOUR RESEARCH. FOCUS ON THE MAIN DISCOVERIES, TRENDS, OR ARGUMENTS THAT EMERGED FROM YOUR STUDY. USE CONCRETE DATA OR SPECIFIC EXAMPLES WHERE APPROPRIATE, BUT MAINTAIN CONCISENESS. THE GOAL IS TO GIVE THE READER A CLEAR UNDERSTANDING OF WHAT YOU FOUND WITHOUT REVEALING EVERY DETAIL.

CONCLUSION AND IMPLICATIONS

FINALLY, THE ABSTRACT SHOULD CONCLUDE WITH A SUMMARY OF YOUR MAIN CONCLUSIONS AND, CRUCIALLY, DISCUSS THEIR BROADER IMPLICATIONS. WHAT DOES YOUR RESEARCH MEAN IN THE LARGER ACADEMIC OR PRACTICAL LANDSCAPE? HOW DOES IT CONTRIBUTE TO EXISTING KNOWLEDGE? THIS SECTION HIGHLIGHTS THE SIGNIFICANCE AND POTENTIAL IMPACT OF YOUR WORK, ENCOURAGING FURTHER EXPLORATION OF YOUR PAPER.

CHICAGO MANUAL STYLE ABSTRACT FORMATTING GUIDELINES

THE CHICAGO MANUAL OF STYLE (CMOS) PROVIDES SPECIFIC GUIDELINES TO ENSURE CONSISTENCY AND PROFESSIONALISM IN ACADEMIC AND PROFESSIONAL WRITING. WHILE CMOS IS COMPREHENSIVE, IT OFTEN DEFERS TO SPECIFIC PUBLISHER OR INSTITUTIONAL REQUIREMENTS FOR ABSTRACTS. HOWEVER, GENERAL PRINCIPLES CAN BE GLEANED FROM ITS EMPHASIS ON CLARITY AND STRUCTURE, WHICH ARE IMPLICITLY APPLIED WHEN FORMATTING A CHICAGO MANUAL ABSTRACT FOR PAPER.

PLACEMENT AND LENGTH

TYPICALLY, AN ABSTRACT IS PLACED AT THE BEGINNING OF A PAPER, IMMEDIATELY AFTER THE TITLE PAGE AND BEFORE THE INTRODUCTION OR MAIN BODY OF THE TEXT. THE LENGTH OF AN ABSTRACT IS USUALLY DICTATED BY THE SPECIFIC SUBMISSION GUIDELINES. HOWEVER, MOST ABSTRACTS RANGE FROM 150 TO 300 WORDS. FOR A CHICAGO MANUAL ABSTRACT FOR PAPER, IT IS CRUCIAL TO CHECK THE WORD COUNT REQUIREMENTS OF YOUR INTENDED AUDIENCE OR PUBLICATION.

PARAGRAPH STRUCTURE

AN ABSTRACT IS GENERALLY PRESENTED AS A SINGLE, SOLID PARAGRAPH. THIS FORMAT REINFORCES THE IDEA OF A CONCISE, UNIFIED SUMMARY OF THE ENTIRE PAPER. AVOID BREAKING THE ABSTRACT INTO MULTIPLE PARAGRAPHS UNLESS SPECIFICALLY INSTRUCTED TO DO SO BY YOUR INSTITUTION OR PUBLISHER. THE FLOW OF IDEAS WITHIN THIS SINGLE PARAGRAPH IS PARAMOUNT.

FONT AND SPACING

WHILE CMOS ITSELF DOES NOT PRESCRIBE SPECIFIC FONTS OR SPACING FOR ABSTRACTS, IT ALIGNS WITH STANDARD ACADEMIC FORMATTING. THEREFORE, IT IS GENERALLY RECOMMENDED TO USE A STANDARD, READABLE FONT SUCH AS TIMES NEW ROMAN OR ARIAL IN 12-POINT SIZE. THE ABSTRACT SHOULD TYPICALLY BE SINGLE-SPACED, WITH A DOUBLE SPACE BETWEEN THE ABSTRACT AND THE MAIN BODY OF THE TEXT. AGAIN, ALWAYS CONFIRM THESE DETAILS WITH YOUR SPECIFIC SUBMISSION GUIDELINES.

CITATIONS

A KEY GUIDELINE FOR ABSTRACTS, INCLUDING THOSE FOLLOWING THE CHICAGO MANUAL ABSTRACT FOR PAPER CONVENTIONS, IS THE AVOIDANCE OF DIRECT CITATIONS. THE ABSTRACT IS MEANT TO SUMMARIZE YOUR OWN WORK. INCLUDING REFERENCES WITHIN AN ABSTRACT CAN BE CONFUSING AND MAY REQUIRE READERS TO CONSULT EXTERNAL SOURCES BEFORE EVEN ACCESSING YOUR MAIN PAPER. IF A SPECIFIC CONCEPT OR PRIOR WORK IS ABSOLUTELY ESSENTIAL TO MENTION, IT IS OFTEN BEST TO REFER TO IT GENERALLY WITHIN THE CONTEXT OF YOUR BACKGROUND OR PROBLEM STATEMENT.

CRAFTING A COMPELLING CHICAGO MANUAL ABSTRACT: BEST PRACTICES

WRITING AN EFFECTIVE CHICAGO MANUAL ABSTRACT FOR PAPER INVOLVES MORE THAN JUST SUMMARIZING YOUR CONTENT; IT REQUIRES STRATEGIC THINKING AND PRECISE EXECUTION. THE GOAL IS TO CREATE A DOCUMENT THAT IS BOTH INFORMATIVE AND PERSUASIVE, DRAWING READERS INTO YOUR RESEARCH. ADHERING TO BEST PRACTICES ENSURES YOUR ABSTRACT ACHIEVES ITS INTENDED PURPOSE.

BE CONCISE AND DIRECT

EVERY WORD IN AN ABSTRACT COUNTS. ELIMINATE JARGON, CLICHÉ S, AND UNNECESSARY WORDS. GET STRAIGHT TO THE POINT AND CONVEY YOUR IDEAS WITH CLARITY AND PRECISION. THIS DIRECTNESS IS A HALLMARK OF EFFECTIVE ACADEMIC WRITING AND IS STRONGLY IMPLIED BY THE CHICAGO MANUAL OF STYLE'S EMPHASIS ON PRECISION.

FOCUS ON THE CORE MESSAGE

IDENTIFY THE ABSOLUTE MOST IMPORTANT ASPECTS OF YOUR RESEARCH: THE CENTRAL QUESTION, THE MOST SIGNIFICANT FINDINGS, AND THE KEY TAKEAWAY. THESE ARE THE ELEMENTS THAT MUST BE PROMINENT IN YOUR ABSTRACT. DON'T GET BOGGED DOWN IN MINOR DETAILS OR TANGENTIAL INFORMATION. THINK ABOUT WHAT A READER ABSOLUTELY NEEDS TO KNOW TO UNDERSTAND THE ESSENCE OF YOUR PAPER.

USE STRONG VERBS AND ACTIVE VOICE

EMPLOYING STRONG VERBS AND ACTIVE VOICE MAKES YOUR WRITING MORE DYNAMIC AND ENGAGING. INSTEAD OF SAYING "THE DATA WAS ANALYZED BY US," OPT FOR "WE ANALYZED THE DATA." THIS CONVEYS A SENSE OF AGENCY AND CONFIDENCE IN YOUR RESEARCH. ACTIVE VOICE ALSO TENDS TO BE MORE CONCISE, FITTING THE ABSTRACT'S NEED FOR BREVITY.

TAILOR TO YOUR AUDIENCE

CONSIDER WHO WILL BE READING YOUR ABSTRACT. ARE THEY EXPERTS IN YOUR SPECIFIC SUBFIELD, OR A BROADER ACADEMIC AUDIENCE? ADJUST YOUR LANGUAGE AND THE LEVEL OF TECHNICAL DETAIL ACCORDINGLY. WHILE MAINTAINING CHICAGO MANUAL ABSTRACT FOR PAPER CONVENTIONS, ENSURE YOUR ABSTRACT IS ACCESSIBLE AND RELEVANT TO ITS INTENDED READERS.

INCORPORATE KEYWORDS NATURALLY

STRATEGICALLY WEAVE IN KEYWORDS THAT ACCURATELY DESCRIBE YOUR RESEARCH. THESE KEYWORDS WILL HELP IN DATABASE SEARCHES AND WILL SIGNAL THE TOPIC OF YOUR PAPER TO POTENTIAL READERS. AVOID SIMPLY LISTING KEYWORDS; INTEGRATE THEM SEAMLESSLY INTO YOUR SENTENCES TO MAINTAIN A NATURAL FLOW.

COMMON MISTAKES TO AVOID IN CHICAGO MANUAL ABSTRACTS

EVEN WITH A CLEAR UNDERSTANDING OF THE PURPOSE AND COMPONENTS OF AN ABSTRACT, IT'S EASY TO FALL INTO COMMON TRAPS THAT CAN DIMINISH ITS EFFECTIVENESS. BEING AWARE OF THESE PITFALLS CAN HELP YOU POLISH YOUR CHICAGO MANUAL ABSTRACT FOR PAPER AND ENSURE IT ACCURATELY REPRESENTS YOUR WORK.

- INCLUDING TOO MUCH DETAIL ABOUT METHODOLOGY THAT IS BETTER SUITED FOR THE MAIN BODY OF THE PAPER.
- MAKING CLAIMS OR DRAWING CONCLUSIONS THAT ARE NOT SUPPORTED BY THE EVIDENCE PRESENTED IN THE PAPER.
- USING JARGON OR HIGHLY TECHNICAL TERMS THAT MAY NOT BE UNDERSTOOD BY A BROADER AUDIENCE, UNLESS THE ABSTRACT IS SPECIFICALLY FOR A NICHE PUBLICATION.
- OMITTING THE KEY FINDINGS OR RESULTS, WHICH ARE THE MOST CRUCIAL ELEMENTS FOR A READER.
- EXCEEDING THE SPECIFIED WORD LIMIT, WHICH CAN LEAD TO THE ABSTRACT BEING TRUNCATED OR REJECTED.
- USING ABBREVIATIONS OR ACRONYMS WITHOUT DEFINING THEM, ASSUMING THE READER WILL BE FAMILIAR WITH THEM.
- INCLUDING INFORMATION ABOUT THE AUTHOR OR ACKNOWLEDGMENTS, WHICH DO NOT BELONG IN AN ABSTRACT.
- FAILING TO PROOFREAD FOR GRAMMATICAL ERRORS, TYPOS, OR AWKWARD PHRASING, WHICH DETRACT FROM THE PROFESSIONALISM OF THE ABSTRACT.

THE ROLE OF KEYWORDS IN YOUR CHICAGO MANUAL ABSTRACT

KEYWORDS ARE FUNDAMENTAL TO THE DISCOVERABILITY AND INDEXING OF YOUR ACADEMIC WORK. WHEN CRAFTING A CHICAGO MANUAL ABSTRACT FOR PAPER, SELECTING AND INTEGRATING RELEVANT KEYWORDS THOUGHTFULLY CAN SIGNIFICANTLY INCREASE THE VISIBILITY OF YOUR RESEARCH. THEY ACT AS SIGNPOSTS, GUIDING READERS AND SEARCH ENGINES TO YOUR CONTENT.

IDENTIFYING RELEVANT KEYWORDS

THE PROCESS OF SELECTING KEYWORDS SHOULD BEGIN EARLY IN YOUR RESEARCH. CONSIDER THE CORE CONCEPTS, THEORIES, METHODOLOGIES, AND SUBJECT MATTER OF YOUR PAPER. THINK ABOUT THE TERMS A RESEARCHER IN YOUR FIELD WOULD USE TO

SEARCH FOR INFORMATION RELATED TO YOUR TOPIC. BROAD TERMS, SPECIFIC TERMS, AND EVEN SYNONYMS CAN BE VALUABLE. FOR A CHICAGO MANUAL ABSTRACT FOR PAPER, IT'S IMPORTANT TO CHOOSE TERMS THAT ACCURATELY REFLECT THE PAPER'S ESSENCE.

INTEGRATING KEYWORDS SEAMLESSLY

THE MOST EFFECTIVE WAY TO USE KEYWORDS IS TO EMBED THEM NATURALLY WITHIN THE SENTENCES OF YOUR ABSTRACT. AVOID SIMPLY LISTING THEM AT THE END, UNLESS EXPLICITLY REQUESTED BY A PUBLISHER. WHEN KEYWORDS APPEAR ORGANICALLY WITHIN THE NARRATIVE OF YOUR ABSTRACT, THEY NOT ONLY IMPROVE SEARCH ENGINE OPTIMIZATION (SEO) BUT ALSO CONTRIBUTE TO THE CLARITY AND COHERENCE OF YOUR SUMMARY. FOR INSTANCE, IF YOUR PAPER IS ABOUT CLIMATE CHANGE ADAPTATION IN URBAN AREAS, KEYWORDS LIKE "CLIMATE CHANGE ADAPTATION," "URBAN RESILIENCE," AND "POLICY INTERVENTIONS" SHOULD BE PRESENT IN A WAY THAT MAKES SENSE WITHIN THE SENTENCES.

THE IMPACT ON DISCOVERABILITY

SEARCH ENGINES AND ACADEMIC DATABASES RELY HEAVILY ON KEYWORDS TO CATEGORIZE AND RETRIEVE RESEARCH PAPERS. WHEN YOUR ABSTRACT CONTAINS THE PRECISE TERMS THAT USERS ARE SEARCHING FOR, YOUR PAPER IS MORE LIKELY TO APPEAR IN THEIR SEARCH RESULTS. THIS INCREASED DISCOVERABILITY IS VITAL FOR ENSURING YOUR RESEARCH REACHES ITS INTENDED AUDIENCE AND CONTRIBUTES TO THE BROADER SCHOLARLY CONVERSATION.

EXAMPLES OF EFFECTIVE CHICAGO MANUAL ABSTRACTS

WHILE THE CHICAGO MANUAL OF STYLE ITSELF PROVIDES GENERAL GUIDELINES RATHER THAN RIGID ABSTRACT TEMPLATES, WE CAN ILLUSTRATE EFFECTIVE ABSTRACT CONSTRUCTION THROUGH HYPOTHETICAL EXAMPLES THAT ALIGN WITH ITS PRINCIPLES OF CLARITY AND PRECISION. THESE EXAMPLES DEMONSTRATE HOW TO SYNTHESIZE KEY INFORMATION INTO A CONCISE AND COMPELLING SUMMARY, AS EXPECTED FOR A CHICAGO MANUAL ABSTRACT FOR PAPER.

EXAMPLE 1: SOCIAL SCIENCE RESEARCH

ABSTRACT: THIS STUDY INVESTIGATES THE IMPACT OF SOCIAL MEDIA ENGAGEMENT ON ADOLESCENT POLITICAL SOCIALIZATION IN THE DIGITAL AGE. FINDINGS INDICATE A SIGNIFICANT CORRELATION BETWEEN CONSISTENT SOCIAL MEDIA USE AND INCREASED EXPOSURE TO POLITICAL INFORMATION, THOUGH THE DEPTH OF UNDERSTANDING VARIES BY PLATFORM. THE STUDY CONCLUDES THAT WHILE SOCIAL MEDIA OFFERS UNPRECEDENTED ACCESS TO POLITICAL DISCOURSE, IT ALSO PRESENTS CHALLENGES RELATED TO MISINFORMATION AND ECHO CHAMBERS, NECESSITATING NEW APPROACHES TO MEDIA LITERACY EDUCATION FOR YOUNG CITIZENS.

EXAMPLE 2: HUMANITIES RESEARCH

ABSTRACT: THIS PAPER RE-EXAMINES THE THEMATIC SIGNIFICANCE OF LIGHT AND SHADOW IN GOTHIC LITERATURE, FOCUSING ON THE WORKS OF ANN RADCLIFFE AND MATTHEW LEWIS. THROUGH A CLOSE TEXTUAL ANALYSIS OF KEY NOVELS, INCLUDING THE MYSTERIES OF UDOLPHO AND THE MONK, THE STUDY ARGUES THAT CHIAROSCURO FUNCTIONS NOT MERELY AS ATMOSPHERIC DEVICE BUT AS A SYMBOLIC REPRESENTATION OF PSYCHOLOGICAL STATES, SOCIETAL REPRESSION, AND THE UNCANNY. BY EXPLORING THE LIMINAL SPACES WHERE LIGHT AND DARKNESS CONVERGE, THIS RESEARCH ILLUMINATES THE GOTHIC SENSIBILITY'S ENGAGEMENT WITH THE AMBIGUITIES OF REASON AND PASSION. THE FINDINGS CONTRIBUTE TO A DEEPER UNDERSTANDING OF THE PSYCHOLOGICAL AND PHILOSOPHICAL UNDERPINNINGS OF THE GOTHIC GENRE.

WHEN IS A CHICAGO MANUAL ABSTRACT REQUIRED?

THE REQUIREMENT FOR AN ABSTRACT, PARTICULARLY ONE ADHERING TO THE CHICAGO MANUAL ABSTRACT FOR PAPER CONVENTIONS, IS NOT UNIVERSAL BUT IS COMMON IN SEVERAL ACADEMIC AND PROFESSIONAL CONTEXTS. UNDERSTANDING WHEN AN ABSTRACT IS EXPECTED ENSURES YOU MEET ALL NECESSARY SUBMISSION CRITERIA.

ACADEMIC PAPERS AND THESES

MOST GRADUATE THESES, DISSERTATIONS, AND OFTEN UNDERGRADUATE RESEARCH PAPERS OR CAPSTONE PROJECTS REQUIRE AN ABSTRACT. THIS IS STANDARD PRACTICE IN ACADEMIA FOR SUMMARIZING EXTENSIVE SCHOLARLY WORK. MANY JOURNALS ALSO MANDATE ABSTRACTS FOR SUBMITTED ARTICLES.

CONFERENCE PRESENTATIONS

WHEN SUBMITTING PROPOSALS FOR ACADEMIC CONFERENCES, AN ABSTRACT IS ALMOST ALWAYS A REQUIRED COMPONENT. IT ALLOWS PROGRAM COMMITTEES TO EVALUATE THE RELEVANCE AND QUALITY OF YOUR PROPOSED PRESENTATION.

GRANT PROPOSALS

GRANT APPLICATIONS FREQUENTLY INCLUDE AN ABSTRACT OR SUMMARY SECTION. THIS PROVIDES A CONCISE OVERVIEW OF THE PROPOSED RESEARCH PROJECT, ITS SIGNIFICANCE, AND ITS EXPECTED OUTCOMES, HELPING REVIEWERS QUICKLY GRASP THE ESSENCE OF THE PROPOSAL.

RESEARCH REPORTS AND TECHNICAL DOCUMENTS

IN PROFESSIONAL SETTINGS, RESEARCH REPORTS, TECHNICAL DOCUMENTS, AND WHITE PAPERS MAY ALSO INCLUDE AN ABSTRACT TO PROVIDE A BRIEF OVERVIEW FOR STAKEHOLDERS WHO MAY NOT NEED TO READ THE ENTIRE DOCUMENT BUT REQUIRE A SUMMARY OF ITS FINDINGS OR RECOMMENDATIONS.

ONLINE PUBLICATION AND DATABASES

AS PREVIOUSLY MENTIONED, ABSTRACTS ARE CRUCIAL FOR ONLINE RESEARCH REPOSITORIES AND DATABASES. THEY SERVE AS THE PRIMARY MEANS OF INDEXING AND MAKING YOUR WORK DISCOVERABLE TO A GLOBAL AUDIENCE.

FAQ

Q: WHAT IS THE PRIMARY PURPOSE OF A CHICAGO MANUAL ABSTRACT FOR PAPER?

A: THE PRIMARY PURPOSE OF A CHICAGO MANUAL ABSTRACT FOR PAPER IS TO PROVIDE A CONCISE AND COMPREHENSIVE SUMMARY OF THE RESEARCH, ALLOWING READERS TO QUICKLY UNDERSTAND THE PAPER'S CONTENT, SCOPE, METHODOLOGY, KEY FINDINGS, AND CONCLUSIONS. IT HELPS READERS DETERMINE THE RELEVANCE OF THE PAPER TO THEIR OWN INTERESTS AND WORK.

Q: ARE THERE SPECIFIC WORD COUNT LIMITATIONS FOR A CHICAGO MANUAL

ABSTRACT?

A: WHILE THE CHICAGO MANUAL OF STYLE ITSELF DOESN'T DICTATE A STRICT WORD COUNT FOR ABSTRACTS, MOST ACADEMIC DISCIPLINES AND PUBLISHERS RECOMMEND A RANGE, TYPICALLY BETWEEN 150 AND 300 WORDS. IT IS CRUCIAL TO CONSULT THE SPECIFIC GUIDELINES OF YOUR INSTITUTION OR PUBLICATION.

Q: SHOULD I INCLUDE CITATIONS WITHIN MY CHICAGO MANUAL ABSTRACT?

A: GENERALLY, CITATIONS SHOULD BE AVOIDED IN AN ABSTRACT. THE ABSTRACT IS A SUMMARY OF YOUR OWN ORIGINAL WORK, AND THE INCLUSION OF REFERENCES CAN BE CUMBERSOME AND MAY REQUIRE READERS TO CONSULT EXTERNAL SOURCES BEFORE ENGAGING WITH YOUR PAPER.

Q: WHAT ARE THE ESSENTIAL COMPONENTS OF A CHICAGO MANUAL ABSTRACT?

A: THE ESSENTIAL COMPONENTS TYPICALLY INCLUDE THE BACKGROUND AND CONTEXT OF THE RESEARCH, THE PROBLEM STATEMENT OR RESEARCH QUESTION, A BRIEF DESCRIPTION OF THE METHODOLOGY, THE KEY FINDINGS OR RESULTS, AND A CONCLUDING STATEMENT ON THE IMPLICATIONS OF THE RESEARCH.

Q: HOW IMPORTANT ARE KEYWORDS IN A CHICAGO MANUAL ABSTRACT?

A: KEYWORDS ARE VERY IMPORTANT. THEY ENHANCE THE DISCOVERABILITY OF YOUR PAPER IN ACADEMIC DATABASES AND SEARCH ENGINES, HELPING RESEARCHERS FIND YOUR WORK WHEN SEARCHING FOR RELEVANT TOPICS. THEY SHOULD BE INTEGRATED NATURALLY INTO THE ABSTRACT'S TEXT.

Q: SHOULD A CHICAGO MANUAL ABSTRACT BE WRITTEN IN THE FIRST OR THIRD PERSON?

A: WHILE THE CHICAGO MANUAL OF STYLE DOES NOT STRICTLY MANDATE PERSON, THIRD-PERSON IS GENERALLY PREFERRED FOR ACADEMIC ABSTRACTS AS IT LENDS A MORE OBJECTIVE TONE. HOWEVER, USING "WE" IS ACCEPTABLE IF REFERRING TO A RESEARCH TEAM. CONSISTENCY IS KEY.

Q: CAN I USE ABBREVIATIONS OR ACRONYMS IN MY CHICAGO MANUAL ABSTRACT?

A: ABBREVIATIONS AND ACRONYMS CAN BE USED, BUT ONLY IF THEY ARE COMMONLY UNDERSTOOD WITHIN THE FIELD OR IF THEY ARE DEFINED UPON THEIR FIRST USE. IT'S GENERALLY BEST TO AVOID THEM IF POSSIBLE TO MAINTAIN CLARITY FOR A WIDER AUDIENCE.
