bibliography system where endnotes (or footnotes) contain full citation information, in the author-date system, the bibliography serves this comprehensive role. For longer works or when citing multiple specific locations, you may need to cite a range of pages. In such cases, the format would be (Author LastName Year, Pages). For instance: The historical context provided a deeper understanding of the event (Garcia 2022,

150–155). If you are citing a source that does not have traditional page numbers, such as some online resources, you might use other locators like chapter or section numbers, following the specific guidelines provided by The Chicago Manual of Style for that type of source. Always consult the latest edition of the manual for the most current and precise instructions.

Handling Multiple Authors

Citing works with multiple authors in the Chicago Manual author-date system requires specific formatting to maintain clarity and adhere to the manual's conventions. For works with two authors, both names are included in the in-text citation, connected by an ampersand. For example: The analysis suggested a correlation (Miller & Thompson 2017).
