The Reference List

The reference list, also known as the "References" section in the author-date system, is a meticulously organized alphabetical list of all sources cited in the text. Each entry in the reference list provides complete bibliographic information, enabling readers to find the original sources. The order of entries is strictly alphabetical by the author's last name. If multiple works by the same author are cited, they are then arranged chronologically by publication year, with the earliest appearing first.

The structure of each reference list entry varies depending on the type of source (e.g., book, journal article, website). However, common elements typically include the author(s), publication date, title of the work, and publication information (e.g., publisher, journal name, URL). The Chicago manual author-date system emphasizes accuracy and completeness in this section, as it serves as the definitive guide to the research underpinning the text.

In-Text Citations in the Chicago Manual Author-Date System

When an organization, institution, or government agency is the author of a work, their name functions as the author in the citation. The full name of the organization should be used unless it is commonly abbreviated and the abbreviation is well-known to the intended audience. In that case, the abbreviation can be used after the first full mention. For subsequent citations, the abbreviation can be used. Example: (World Health Organization 2017). If the organization is widely known, subsequent citations might appear as (WHO 2017), but the first mention should be full. The reference list entry would also use the full name.

Citing Indirect Sources

An indirect source refers to a work that is cited in another work you are consulting, and you were unable to access the original source. The Chicago Manual Author-Date system advises against using indirect sources if at all possible, as it can lead to inaccuracies. However, if it is unavoidable, you should cite both the original source and the secondary source. The in-text citation format typically indicates this clearly. For instance: (Johnson 2015, as cited in Williams 2019, 88). In the reference list, you only list the source you consulted (Williams 2019), not the original work by Johnson.

For online journal articles, include a DOI or URL if available. Example: Lee, Chen. 2022. "Renewable Energy Policies." *Environmental Science Quarterly* 35 (1): 88-105.

Websites and Online Content

Citing online sources requires careful attention to detail. For web pages with an author, the format is similar to articles but includes retrieval information: Last Name, First Name. Year. "Title of Web Page." *Title of Website*. Last Modified Date (if available). Accessed Month Day, Year. URL.

Example: Garcia, Maria. 2023. "Understanding Climate Change." *National Geographic*. Accessed October 26, 2023. <https://www.nationalgeographic.com/environment/climate-change/>.

If no author is listed for a web page, start with the title of the page, treating it as the author.

Example: "Latest Findings in Astronomy." 2021. *Space Today*. Accessed October 26, 2023. <https://www.spacetoday.com/astronomy-news/>.
