Understanding the Chicago Manual of Style Endnote System

Edited Book

If you are citing a specific chapter within an edited book, you will cite the chapter author and title, followed by the edited book's title and publication information.

- Example: 3. Mary Johnson, "The Evolution of Narrative," in *A Collection of Essays on Modern Literature*, ed. John Smith (New York: Oxford University Press, 2018), 112-130.

Subsequent Citations

For sources that have already been cited in full, Chicago style allows for shortened citations in subsequent endnotes. This prevents redundancy and makes the notes more concise.

- Example (for the single-author book mentioned earlier): 4. Doe, *History of Citation Styles*, 78.
- Example (for the chapter mentioned earlier): 5. Johnson, "Evolution of Narrative," 115.

Journal Article Citation Examples in Endnotes

Journal articles are a common source in academic writing, and their citation in endnotes follows specific Chicago style guidelines. The key distinction is that the article title is in quotation marks, while the journal title is italicized.

Full Journal Article Citation

Similar to books, subsequent citations of journal articles are shortened to improve readability.

- Example: 7. Davis, "Social Media," 235.

If the author has multiple articles in the same journal, or multiple articles with the same title, you might need to include a more descriptive shortened title to distinguish them. The goal is always clarity and ease of retrieval for the reader.

Website and Online Resource Citation Examples in Endnotes

Citing online resources requires attention to detail, as the information

Webpage Citation

- Example: 9. Michael Brown, "The Future of Artificial Intelligence," TechToday, January 10, 2022, <https://www.techtoday.com/future-of-ai>.

Including the URL and access date ensures that the reader can locate the exact information you consulted. If the article has a DOI, it should be included instead of the URL for greater stability.

Other Common Source Type Examples in Endnotes

Beyond books and journal articles, academic research often involves a wider array of sources, each requiring specific citation formats in Chicago endnotes.

Newspaper Article

When citing a newspaper article, include the author's name (if bylined), the article title, the newspaper name in italics, the date of publication, and the page number(s). For online newspaper articles, include the URL and access date.

Dissertation or Thesis

Citing a dissertation or thesis involves identifying the author, the title of the work in italics, its type (e.g., PhD dissertation, master's thesis), the institution, and the year of completion. If accessed online, include the database or repository and URL.

- Example: 12. Emily Watson, *The Impact of Urban Green Spaces on Mental Health* (PhD dissertation, University of Chicago, 2022).
- Example (online): 13. John Miller, *Analysis of Climate Change Data Patterns* (Master's thesis, Stanford University, 2021), ProQuest Dissertations and Theses Global.

Conference Paper

For conference papers, cite the author, the paper title in quotation marks, the name of the conference, the location, and the date, followed by the page number(s) if available.

- Example: 14. Robert Green, "Innovations in Renewable Energy Storage," presented at the International Conference on Sustainable Technologies, Berlin, Germany, September 15, 2023.

Variations and Special Cases in Endnote Formatting

The Chicago Manual of Style acknowledges that not all sources fit neatly into standard categories. There are specific rules for less common formats and situations that require careful application of the principles outlined in the manual.

Works with Multiple Authors

For works with two or three authors, list all their names in the endnote. For works with more than three authors, list the first author followed by "et al." (and others).

- Example (four authors): 16. P. R. Adams et al., *Advanced Statistics for Social Sciences* (Boston: Pearson, 2017), 150.

Works with Corporate Authors

If an organization or corporation is the author, list its name in place of an individual author's name.

- Example: 17. World Health Organization, *Global Health Report 2022* (Geneva: WHO, 2022), 30.

Legal and Government Documents

These have highly specialized citation formats that are detailed in the Chicago Manual of Style. For instance, citing a court case or a government report involves specific terminology and structure.

- Example (statute): 18. Clean Air Act, 42 U.S.C. § 7401 et seq. (1963).
- Example (court case): 19. *Marbury v. Madison*, 5 U.S. 137 (1803).

A: The access date is crucial for online resources because web content can be updated or removed without notice. Including the access date indicates when you viewed the material, providing a timestamp for your research and allowing others to verify the information as it existed at that time.
