UNDERSTANDING THE FOUNDATIONS OF EXEGESIS

THE CHICAGO MANUAL FOR EXEGESIS CHAMPIONS A METHODOLOGY THAT IS BOTH THOROUGH AND PURPOSEFUL.

THE ROLE OF TEXTUAL CRITICISM IN EXEGESIS

WITHOUT THIS HISTORICAL LENS, INTERPRETATIONS CAN EASILY BECOME ANACHRONISTIC, IMPOSING MODERN SENSIBILITIES ONTO ANCIENT THOUGHT.
