Understanding the Author-Date System

In the reference list for works with many authors, Chicago style generally recommends listing all authors up to a certain number (often ten) and then using "et al." after the last listed author.

Edited Books

For edited books, the citation format slightly shifts to acknowledge the editor(s) rather than the author(s) of the entire work. In the in-text citation, you will use the editor's last name and the year, followed by "ed." or "eds." if necessary for clarity, and the page number for direct quotes. For instance, (Green, ed., 2018, 112). The reference list entry will prominently feature the editor's name, followed by ", ed." or ", eds.", then the publication year, the title of the book (italicized), and finally the publication information. For example: Green, Robert, ed. 2018. *Essays on Modern Literature*. New York: Academic Publishers.

Citing Journal Articles in Author-Date Style

Journal articles are frequently cited in academic work, and the Chicago author-date system provides clear guidelines for their inclusion. The in-text citation for a journal article typically includes the author's last name, the publication year, and for direct quotations, the page number. For example, if citing a study by Chen published in 2020, the in-text citation would be (Chen 2020). If quoting, it would be (Chen 2020, 55).

The reference list entry for a journal article requires more detail than a book citation. Online Journal Articles

If a DOI is not available for an online journal article, the URL and the date of access may be included. Citing Web Sources and Online Materials

Websites with No Clear Author or Date

When an author or publication date for a web source is unavailable, the Chicago author-date system provides alternatives. In the in-text citation, you may use the title of the webpage or the name of the organization responsible for the site, along with an estimated date if appropriate, or the term "n.d." (no date) if no reasonable estimation can be made. For example, (World Wildlife Fund n.d.) or (Global Health Initiative, ca. 2021). In the reference list, the absence of an author is handled by moving the title to the author position. If no date is available, "n.d." is used in place of the year. The URL and access date remain important components. For instance: About Bees. n.d. "The Importance of Bees for Pollination." <https://www.aboutbees.org/pollination>. Accessed November 1, 2023.

Other Common Source Types

Beyond books and journal articles, academic writing often incorporates a variety of other sources, each requiring specific citation formats under the Chicago author-date system. This includes citing dissertations, conference proceedings, government documents, and even interviews. The fundamental principle of linking an in-text citation to a detailed reference list entry remains consistent across all source types, ensuring a complete and accurate record of all consulted materials.

Dissertations and Theses
