THE NOTES-BIBLIOGRAPHY SYSTEM, OFTEN PREFERRED IN THE HUMANITIES, USES FOOTNOTES OR ENDNOTES TO CITE SOURCES WITHIN THE TEXT, FOLLOWED BY A COMPREHENSIVE BIBLIOGRAPHY AT THE END. THE AUTHOR-DATE SYSTEM, COMMON IN THE SOCIAL SCIENCES AND NATURAL SCIENCES, USES PARENTHETICAL CITATIONS WITHIN THE TEXT (AUTHOR, YEAR, PAGE NUMBER) AND A REFERENCE LIST AT THE END. UNDERSTANDING THE NUANCES OF EACH SYSTEM AND APPLYING THEM CORRECTLY IS ESSENTIAL FOR ACADEMIC INTEGRITY AND SCHOLARLY COMMUNICATION.

## THE NOTES-BIBLIOGRAPHY SYSTEM

IN THE NOTES-BIBLIOGRAPHY SYSTEM, A SUPERScript NUMBER IS PLACED IN THE TEXT IMMEDIATELY FOLLOWING THE MATERIAL BEING CITED. THIS NUMBER CORRESPONDS TO A NOTE (EITHER A FOOTNOTE AT THE BOTTOM OF THE PAGE OR AN ENDNOTE AT THE END OF THE CHAPTER OR BOOK) THAT PROVIDES THE FULL CITATION INFORMATION. A BIBLIOGRAPHY, LISTING ALL SOURCES CITED AND SOMETIMES CONSULTED, APPEARS AT THE END OF THE WORK. THIS SYSTEM ALLOWS FOR DETAILED ANNOTATIONS AND COMMENTARY IN THE NOTES, MAKING IT PARTICULARLY USEFUL FOR EXTENSIVE RESEARCH AND DETAILED ANALYSIS.

## THE AUTHOR-DATE SYSTEM

THE AUTHOR-DATE SYSTEM OFFERS A MORE CONCISE METHOD OF CITATION WITHIN THE TEXT. PARENTHETICAL CITATIONS, TYPICALLY INCLUDING THE AUTHOR'S LAST NAME AND THE YEAR OF PUBLICATION, ARE INSERTED DIRECTLY INTO THE SENTENCE. FOR SPECIFIC QUOTATIONS OR PARAPHRASED IDEAS, THE PAGE NUMBER IS ALSO INCLUDED. THIS SYSTEM IS FOLLOWED BY A REFERENCE LIST AT THE END OF THE DOCUMENT, WHICH CONTAINS FULL BIBLIOGRAPHIC INFORMATION FOR EACH CITED WORK, ORGANIZED ALPHABETICALLY BY AUTHOR'S LAST NAME.

## ELEMENTS OF A CHICAGO STYLE CITATION

REGARDLESS OF THE CHOSEN SYSTEM, CHICAGO STYLE CITATIONS TYPICALLY INCLUDE SEVERAL CORE ELEMENTS TO IDENTIFY A SOURCE COMPLETELY. THESE ELEMENTS, THOUGH THEIR ORDER AND PRESENTATION VARY BETWEEN THE NOTES-BIBLIOGRAPHY AND AUTHOR-DATE SYSTEMS, GENERALLY INCLUDE:

- AUTHOR(S) NAME(S)
- TITLE OF THE WORK
- PUBLICATION INFORMATION (PUBLISHER, PLACE OF PUBLICATION, YEAR)
- PAGE NUMBERS FOR SPECIFIC REFERENCES
- INFORMATION FOR ONLINE SOURCES (URLS, DOIs, ACCESS DATES)
