Understanding the Two Chicago Citation Systems

The Chicago Manual of Style (CMOS) 17th edition offers two distinct citation systems to accommodate different academic disciplines and publication preferences. The first, and often more traditional in humanities, is the notes-bibliography system. The second, prevalent in the sciences and social sciences, is the author-date system. Each system has its own set of rules for in-text citations and the final list of sources, but both aim for accuracy, completeness, and ease of use for readers trying to locate the original material. Citing online content requires careful attention to detail, as website structures and content can change. Key elements include the author (if available), the title of the specific page or article, the website name, the publication or last updated date (if available), and the URL.

CMOS also provides guidance for a variety of other sources, including reports, dissertations, and interviews. The core principle remains to provide enough information for the reader to locate the original source.

The Author-Date System: In-Text Citations and Reference List Entries

The author-date system, widely adopted in scientific and social science fields, uses brief in-text citations that refer readers to a comprehensive reference list at the end of the document. This system prioritizes providing source information efficiently within the flow of the text, allowing for quick verification of claims.

In-text citations typically include the author's last name and the year of publication. If a specific part of the source is being referenced, the page number is also included. The reference list at the end of the document contains full bibliographic details for every source cited in the text, presented in alphabetical order by author's last name.
