HYPHENATION RULES HAVE ALSO SEEN CAREFUL CONSIDERATION IN THE UPDATED EDITION. FOR EXAMPLE, "A WELL-KNOWN AUTHOR" IS CORRECT, BUT "THE AUTHOR IS WELL KNOWN." THE 17TH EDITION OFFERS UPDATED EXAMPLES TO ILLUSTRATE THESE NUANCES, REFLECTING CURRENT USAGE.

GRAMMAR AND USAGE: EVOLVING LANGUAGE
