THE AUTHOR-DATE SYSTEM USES IN-TEXT PARENTHETICAL CITATIONS (E.G., (SMITH 2023)) AND A REFERENCE LIST AT THE END. THE NOTES-BIBLIOGRAPHY SYSTEM IS GENERALLY PREFERRED IN HUMANITIES FIELDS, WHILE AUTHOR-DATE IS COMMON IN THE SCIENCES.

Q: HOW DOES A CHICAGO MANUAL OF STYLE 17TH EDITION WRITER HANDLE CAPITALIZATION OF TITLES?

A: A CHICAGO MANUAL OF STYLE 17TH EDITION WRITER FOLLOWS SPECIFIC RULES FOR CAPITALIZING TITLES OF WORKS (BOOKS, ARTICLES, ETC.) AND HEADINGS.
