THE GOAL IS TO ENCOURAGE DELIBERATE AND EFFECTIVE CHOICES RATHER THAN A BLANKET AVOIDANCE OR OVERUSE OF EITHER VOICE.

CITATION STYLES: NOTES AND BIBLIOGRAPHIES

THE NOTES AND BIBLIOGRAPHY SYSTEM, ONE OF THE TWO PRIMARY CITATION METHODS DETAILED IN THE CHICAGO MANUAL OF STYLE 18TH EDITION, IS FAVORED IN MANY ACADEMIC DISCIPLINES, PARTICULARLY WITHIN THE HUMANITIES. THIS SYSTEM INVOLVES USING NUMBERED FOOTNOTES OR ENDNOTES TO CITE SOURCES WITHIN THE TEXT, WITH A COMPREHENSIVE BIBLIOGRAPHY AT THE END OF THE WORK THAT LISTS ALL SOURCES CITED. THE AUTHOR-DATE SYSTEM IS OFTEN PREFERRED FOR ITS EFFICIENCY AND CONCISENESS, ESPECIALLY IN FIELDS WHERE RESEARCH IS HEAVILY RELIANT ON A VAST BODY OF EXISTING LITERATURE. THE PARENTHETICAL CITATIONS ALLOW READERS TO QUICKLY IDENTIFY THE SOURCE AND PUBLICATION DATE OF INFORMATION WITHOUT DISRUPTING THE FLOW OF THE TEXT AS SIGNIFICANTLY AS LONGER NOTES MIGHT.
