The Bibliography

The bibliography, located at the end of the paper, lists all the sources cited in the notes, presented in alphabetical order by the author's last name. Unlike the notes, the bibliography entries are presented in a consistent format, with the author's last name appearing first, followed by the first name. The bibliography serves as a complete reference list for readers who wish to consult the sources used.

A typical bibliography entry for a book under the notes-bibliography system resembles:

- Foucault, Michel. *Discipline and Punish: The Birth of the Prison*. Translated by Alan Sheridan. New York: Vintage Books, 1995.

The Author-Date System: Parenthetical Citations and Reference Lists

The author-date system, prevalent in the social sciences and some natural sciences, uses parenthetical citations within the text and concludes with a reference list. This method is often favored for its conciseness and ease of integration into scientific and empirical writing.

In-Text Citations: Parenthetical References

In the author-date system, in-text citations appear in parentheses, typically including the author's last name, the year of publication, and the page number (if applicable). If the author's name is mentioned in the text, only the year and page number are needed in the parentheses:

The Reference List

The reference list, appearing at the end of the document, enumerates all the sources cited in the text, again alphabetized by author's last name. Each entry in the reference list provides complete bibliographic details necessary for the reader to locate the original source. The format for reference list entries differs slightly from bibliography entries in the notes-bibliography system, particularly in the capitalization and punctuation.

A sample reference list entry for the same book:

- Foucault, Michel. 1995. *Discipline and Punish: The Birth of the Prison*. Translated by Alan Sheridan. New York: Vintage Books.

General Principles of Chicago Style Citation

For the bibliography, the author's last name comes first, followed by a comma, then the first name. The title is still italicized, and the publication details follow.

- **Bibliography:** Doe, Jane. *The Art of Citation*. Chicago: University of Chicago Press, 2020.

For books with multiple authors, editors, or translators, specific rules apply. For two authors, both

are listed. For three or more, the first author is listed, followed by "et al." in notes, and the first author followed by "et al." in the bibliography.

Author-Date System for Books

In the author-date system, book citations in the text are brief parenthetical references. The reference list entry includes the author's last name, first name, the year of publication in parentheses, the italicized title, and publication information.

- **Parenthetical:** (Doe 2020, 55)
- **Reference List:** Doe, Jane. 2020. *The Art of Citation*. Chicago: University of Chicago Press.

Again, handling multiple authors or editors follows specific patterns, often listing all authors in the reference list if there are two or three, and using "et al." for four or more.

Citing Journal Articles in Chicago Style

Journal articles are essential for referencing current research and scholarly discourse. Chicago manual of style academic paper citation requirements for journal articles are distinct due to the inclusion of volume, issue, and page ranges.

Notes-Bibliography System for Journal Articles

Note the inclusion of the article's page range in the bibliography entry, and the DOI or stable URL if available.

Author-Date System for Journal Articles

The parenthetical citation includes the author's last name and publication year. The reference list entry will contain the author's name, year of publication, article title, journal title, volume, issue, and page range, along with any DOI or URL.

- **Parenthetical:** (Smith 2021, 112)
- **Reference List:** Smith, John. 2021. "A Study of Citation Habits." *Journal of Academic Writing* 15, no. 2: 110-35. <https://doi.org/10.xxxx/jaw.2021.001>.

Citing Web Resources in Chicago Style

The digital age presents unique challenges for citation, as web content can be dynamic and sometimes lacks traditional publication details. Chicago manual of style academic paper citation requirements for websites aim to provide as much identifying information as possible.

Notes-Bibliography System for Web Resources

For online sources, include the author (if known), the title of the specific page or document (in quotation marks), the title of the overall website (italicized), the publication date or last updated date, and the URL. Crucially, include the date you accessed the material, as web content can change.

Citing Other Common Source Types
