Journal Articles

Journal article entries include the author's name, the publication year in parentheses, the article title (in quotation marks), the journal title (italicized), the volume and issue numbers, and the page range of the article. For example:

Davis, Emily. 2019. "Technological Advancements in Education." *Journal of Modern Learning* 15 (3): 78-95.

Websites

Citing online sources requires providing the author (if known), the publication or last updated date, the title of the specific page or article (in quotation marks), the website name (italicized), and the URL. It is also recommended to include a date of access. For example:

World Health Organization. 2023. "Global Health Trends." Accessed October 26, 2023.
<https://www.who.int/trends>.

Chapters in Edited Books

When citing a chapter from an edited book, you list the chapter author, the chapter title, the word "in," the editor(s) name(s) (preceded by "ed." or "eds."), the book title (italicized), and then the page range of the chapter and publication details. For example:

Miller, Sarah. 2021. "The Evolution of Argumentation." In *Contemporary Rhetorical Theory*, edited by Robert Brown, 115-40. New York: Routledge.

Dissertations and Theses

Entries for dissertations and theses include the author's name, the year of completion, the dissertation title (italicized), and information about the institution and type of work (e.g., PhD diss., Master's thesis) and its availability. For example:

Chen, Wei. 2018. *Sustainable Urban Development Models*. PhD diss., University of California, Berkeley.
