Books with Four or More Authors

For books with four or more authors, CMOS generally recommends listing the first author's name followed by "et al." (meaning "and others").

- Last Name, First Name, et al. *Title of Book*. City of Publication: Publisher, Year.

An example:

Garcia, Maria, et al. *The Art of Storytelling*. London: Penguin Books, 2019.

Edited Books

When citing an edited book, the editor's name(s) are included. The format distinguishes between an editor and an author.

Books Published by Organizations or Institutions

When a book is published by an organization rather than a traditional publisher, or when the organization acts as the author, the format reflects this.

- Organization Name. *Title of Book*. City of Publication: Organization Name, Year.

Example:

World Health Organization. *Global Health Report 2023*. Geneva: World Health Organization, 2023.

The Author-Date System: Concise Citations for Books

The author-date system, commonly used in social sciences and some natural sciences, provides a more abbreviated citation in the bibliography, with full details provided only if necessary or in a separate reference list. The primary citation in the text is typically an in-text citation (Author Year, Page).

Structure of a Bibliography Entry for a Book (Author-Date System)

Edited Books

Edited books are cited by the editor(s).

- Editor Last Name, First Name, ed. Year. *Title of Book*. City of Publication: Publisher.

Example:

Chen, Li, ed. 2021. *Contemporary Asian Literature*. Singapore: National University of Singapore Press.

Translated Books

Translator information is included for translated works.

- Original Author Last Name, First Name. Year. *Title of Book*. Translated by Translator First Name Last Name. City of Publication: Publisher.

Here's how it looks:

Dostoevsky, Fyodor. 2002. *Crime and Punishment*. Translated by Constance Garnett. New York: Modern Library.

Reprinted Books or Editions

When citing reprinted works or specific editions, the original publication year might be included, followed by the reprint details.

- Author Last Name, First Name. Year. *Title of Book*. Edition Number ed. City of Publication: Publisher.

Example:

King, Stephen. 2011. *The Shining*. 2nd ed. New York: Doubleday.
