Example with multiple companies:

Nolan, Christopher, dir. *Inception*. United States and United Kingdom, 2010. Warner Bros. Pictures, Legendary Pictures, Syncopy.

In this example, the film was produced by more than one entity, and all are listed. The country of origin might also be a list if the film had international co-production.

Citing Films from Different Sources

The way a film is accessed can significantly influence how it is cited in your bibliography. Chicago style provides specific guidelines for different media, ensuring that the source from which you viewed the film is clearly indicated.

Citing Films Available on Streaming Services

Streaming services have become a primary way to access films. When citing a film found on a platform like Netflix, Hulu, or Amazon Prime Video, you need to include details about the service and how to access it.

Format for Streaming Services:

Director's Last Name, First Name, dir. *Film Title*. Country of Origin, Year of Release. Production Company. Accessed Month Day, Year. Streaming Service Name. URL (if stable or required).

Example:

Villeneuve, Denis, dir. *Blade Runner 2049*. United States and Canada, 2017. Warner Bros. Pictures, Columbia Pictures, Alcon Entertainment. Accessed October 26, 2023. Netflix.

It's important to note that including the URL for streaming services is often optional, especially if the content is widely available or behind a paywall. However, if the content is unique or has a persistent link, it can be helpful to include. Always check your instructor's or publisher's specific requirements regarding URLs for streaming content.

Citing Films on DVD or Blu-ray

When citing physical media such as DVDs or Blu-rays, the focus shifts to the details of the disc itself, including the distributor and the specific edition.

Format for DVD/Blu-ray:

Director's Last Name, First Name, dir. *Film Title*. Country of Origin, Year of Release. Production Company. DVD or Blu-ray disc. Distributor Name, Year of Distribution.

Example:

Fincher, David, dir. *The Social Network*. United States, 2010. Columbia Pictures. DVD. Sony Pictures Home Entertainment, 2011.

Here, "DVD" or "Blu-ray disc" clearly indicates the format. The distributor and the year it was released on that specific format are also provided.

Citing Films from Online Video Platforms (e.g., YouTube)

Films or clips hosted on general video platforms like YouTube require careful citation, as these

sources can be less stable and have varying levels of quality and authorization.

Format for Online Video Platforms:

Director's Last Name, First Name, dir. *Film Title*. Country of Origin, Year of Release. Production Company. Accessed Month Day, Year. YouTube video, added by User Name. URL.

Example:

Chaplin, Charlie, dir. *The Kid*. United States, 1921. First National Pictures. Accessed October 26, 2023. YouTube video, added by The Silent Film Channel.

When citing from platforms like YouTube, it is crucial to verify the uploader's legitimacy and the accuracy of the uploaded content. If the film is officially available from a studio or distributor on the platform, it's preferable to cite that official source.

Handling Special Cases in Film Citations

Beyond the standard film entries, Chicago style also accommodates specific situations, such as citing documentaries, short films, or films where the director is unknown or not the primary focus.

Citing Documentaries

Documentaries are cited similarly to narrative films, but it's often helpful to specify that it is a documentary in the entry, especially if the title doesn't immediately suggest it.

Format for Documentaries:

Director's Last Name, First Name, dir. *Documentary Title*. Country of Origin, Year of Release. Production Company. Type of Film (e.g., Documentary film).

Including "Documentary film" adds clarity, though it's not always mandatory if the title or subject matter makes it obvious.

Citing Short Films

Short films, often found in collections or as supplementary material, have their own citation conventions.

Format for Short Films:

Director's Last Name, First Name, dir. *Short Film Title*. Country of Origin, Year of Release. Production Company. If part of a larger collection, provide details of the collection.

Example (as part of a compilation):

Smith, Jane, dir. *The Last Leaf*. United States, 2019. Independent. In *Best Shorts of the Year*, directed by various directors. Film Festival Productions, 2020. DVD.

If the short film is standalone, the format is similar to a regular film entry. The context of its presentation is key.

Citing Films Without a Known Director

In rare cases, the director of a film may be uncredited or unknown. In such instances, the citation should begin with the title.

Format for Films Without a Known Director:

Film Title. Country of Origin, Year of Release. Production Company.

Example:

The French Dispatch. United States, 2021. Fox Searchlight Pictures. (Note: This is an example, Wes Anderson is the director of *The French Dispatch*, but used here hypothetically for format demonstration).

This structure prioritizes the film title when the director is not a primary identifier.

In-Text Citations for Films

Proper in-text citation is as crucial as the bibliography. It guides your reader to the exact source of information within your text, enabling them to locate the full entry in your bibliography.

Methods for In-Text Citation

Chicago style generally uses a parenthetical citation system or endnotes/footnotes. For films, you typically cite the director and the year of release. When referring to a specific scene or quoting dialogue from a film, you may need to include additional information in your in-text citation to help the reader pinpoint the exact moment.

Example with Scene Reference:

The tension builds as Rick makes his difficult decision, a pivotal moment in the film's narrative (Curtiz 1942, scene 87).

Alternatively, you might use timestamps if the version of the film you are referencing has consistent timestamps:

The dramatic airport farewell takes place around the 1:40:00 mark (Curtiz 1942, 1:40:00).
