Understanding the Chicago Manual of Style Bibliography

The bibliography in Chicago style, often referred to as the "Works Cited" list, serves as a comprehensive record of all the sources you have consulted and cited in your paper. It is typically placed at the end of your document and is alphabetized by the author's last name (or by title if no author is listed). Books

- **Single Author Book:**

- **Two or Three Authors:**

Doe, Jane, and Richard Roe. *Advanced Research Methods*. New York: Oxford University Press, 2019.

- **Four or More Authors:**

For four or more authors, list the first author followed by "et al." (and others) in the bibliography. In the notes, you would list all authors the first time and then use "et al." thereafter. However, for the bibliography, the convention is to list the first author and then "et al."

- **Edited Book:**

When citing an edited book where you are referencing the entire work, you list the editor(s). If you are citing a specific chapter, you would cite the chapter author and then the edited book.

Miller, Sarah, ed. *Perspectives on Digital Humanities*. Berkeley: University of California Press, 2021.

- **Book with an Editor and Author (of a specific work within the book):**

This scenario applies when citing a chapter or essay from an edited collection. The bibliography entry for the chapter author typically comes first, followed by the title of the chapter in quotation marks, and then information about the book itself.

Journal Articles

Journal articles are a vital part of academic discourse. When citing them in a Chicago style bibliography, include the author(s), the article title in quotation marks, the journal title italicized, the volume and issue numbers, the year of publication, and the page range. For online journal articles accessed via a database or DOI, include the DOI or URL.

- **Print Journal Article:**

- **Online Journal Article with DOI:**

When a DOI (Digital Object Identifier) is available, it is the preferred way to cite online journal articles as it provides a stable link. The format is similar to print articles but includes the DOI at the end.

- **Online Journal Article without DOI (from a database):**

If no DOI is provided, use the URL of the article or the database from which it was accessed, along with the access date. It is generally recommended to use the DOI if available.

Book Chapters

Citing individual chapters within edited collections is common. The format emphasizes the chapter author and title, followed by the details of the larger edited work.

Johnson, Robert. "Historical Perspectives on Urban Development." In *Cities of the Future*, edited by Angela White, 78–99. New York: Routledge, 2019.

Websites and Online Sources

The dynamic nature of the internet necessitates clear guidelines for citing online resources. Key information includes the author (if available), the title of the specific page or article, the name of the website, the publication or last updated date (if available), and the URL. Crucially, include the date you accessed the material.

- **Webpage with Author and Date:**

Davis, Sarah. "Understanding Climate Change." National Geographic, January 10, 2023. Accessed December 15, 2023.
<https://www.nationalgeographic.com/environment/climate-change-explained>.

- **Website without Author or Specific Date:**

When an author or specific publication date is not readily apparent, you may need to omit these elements or use the website's general information.

Alphabetize by the website's title.

- **Online Report:**

Newspaper and Magazine Articles

Newspaper and magazine articles are cited similarly, but with less emphasis on the volume/issue numbers and more on the date and page numbers (for print). For online articles, a URL is included.

- **Newspaper Article (Print):**

Miller, Laura. "New Subway Line to Open Next Year." *Chicago Tribune*, December 10, 2023, sec. A1.

- **Magazine Article (Online):**

Lee, Kevin. "The Future of Remote Work." *Wired*, November 2023. Accessed December 15, 2023. <https://www.wired.com/story/future-of-remote-work>.

Other Common Sources

Chicago style also provides formats for less common sources such as dissertations, theses, conference proceedings, and government documents.

- **Dissertation or Thesis:**

Taylor, Andrew. "The Impact of Technology on Education." PhD diss., University of Illinois, 2022.

- **Conference Paper:**

Roberts, Sarah. "Ethical Considerations in AI Development." Paper presented at the International Conference on Artificial Intelligence, San Francisco, CA, October 2023.

United States. Department of Justice. *Report on Crime Statistics*. Washington, DC: Government Printing Office, 2021.

Key Differences: Notes vs. Author-Date System

For example, a book in Author-Date might look like: Smith, John. 2020. *The Art of Citation: A Comprehensive Guide*. Chicago: University of Chicago Press.
