Citing Books in Chicago Style

For the notes-bibliography system, a full note for a book would typically include:

- Author's full name (first and last).

The corresponding bibliography entry would omit the page numbers cited but would generally follow a similar order for author, title, and publication details, often with the author's last name first for alphabetical sorting.

Citing Edited Books

Citing Chapters in Edited Books

The author-date system reference list entry would be: Doe, Jane. 2019. "The Renaissance Masters." In *The History of Art*, ed. John Smith, 75-90. New York: Penguin Books.

Citing Periodicals (Journals and Magazines)

Citing articles from academic journals, magazines, and newspapers requires specific formatting to distinguish them from books. Key information includes the author, article title, periodical title, volume and issue numbers (for journals), date of publication, and page numbers.

Citing Journal Articles

For the notes-bibliography system, a journal article citation in a note would typically include: Author's full name, "Article Title," Journal Title volume, issue (Year): page number(s). For example: Sarah Lee, "The Impact of Social Media," *Journal of Digital Studies* 15, no. 2 (2021): 112.

The corresponding bibliography entry would be: Lee, Sarah. "The Impact of Social Media." *Journal of Digital Studies* 15, no. 2 (2021): 105-120.

In the author-date system, the in-text citation would be (Lee 2021, 112). The reference list entry would be: Lee, Sarah. 2021. "The Impact of Social Media." *Journal of Digital Studies* 15

(2): 105-120.

Citing Magazine and Newspaper Articles

Magazine and newspaper articles are cited similarly but typically omit volume and issue numbers. The focus is on the publication date and page number. For a note: Michael Brown, "Urban Renewal Projects," *The City Chronicle*, April 15, 2023, A4.

For a reference list entry: Brown, Michael. "Urban Renewal Projects." *The City Chronicle*, April 15, 2023, A4.

The author-date system would use (Brown 2023, A4) for an in-text citation, with a reference list entry similar to the notes-bibliography format but with the author's last name first: Brown, Michael. 2023. "Urban Renewal Projects." *The City Chronicle*, April 15, A4.

Citing Online Sources

The digital landscape presents unique challenges for citation. The Chicago Manual of Style, 17th edition, provides guidelines for citing websites, online articles, and other digital content. Key elements for online sources often include the author (if available), title of the specific page or article, the website name, and a stable URL or DOI. When citing online sources, it's crucial to include the most stable and persistent identifier.

For the notes-bibliography system, an example for a webpage might be: Emily Davis, "Understanding AI Ethics," *Tech Insights*, accessed October 26, 2023, <https://www.techinsights.com/ai-ethics>.

The corresponding bibliography entry would be: Davis, Emily. "Understanding AI Ethics." *Tech Insights*. Accessed October 26, 2023. <https://www.techinsights.com/ai-ethics>.

In the author-date system, the in-text citation could be (Davis 2023). The reference list entry would follow a similar pattern to the bibliography entry above, with the author's last name first.

Citing E-books

E-books are cited similarly to print books, but often include information about the e-book format or platform and a URL or DOI if applicable. For a note: Robert Green, *Digital Marketing Strategies* (2022), Kindle edition, <https://www.amazon.com/digital-marketing>.

For a bibliography entry: Green, Robert. *Digital Marketing Strategies*. 2022. Kindle edition. <https://www.amazon.com/digital-marketing>.

The author-date system would use (Green 2022) and the reference list entry would mirror the bibliography format.

Citing Other Source Types

The Chicago Manual of Style covers a vast array of source types beyond books and periodicals. This includes citing dissertations, theses, government documents, interviews, lecture notes, films, music, and artwork. The core principle remains the same: provide enough information for the reader to locate the source.

Citing Dissertations and Theses

When citing dissertations or theses, include the author's name, the title of the work (in italics), the degree sought, the university, and the year of completion. If the dissertation is published and available through a database like ProQuest, include that information. For a note: John Adams, "*The Evolution of Urban Planning*" (PhD diss., University of Chicago, 2020), ProQuest Dissertations Publishing.

In the author-date system, the reference list entry would be: Adams, John. 2020. "*The Evolution of Urban Planning*." PhD diss., University of Chicago. ProQuest Dissertations Publishing.

Citing Interviews

Interviews are often considered unpublished works. For a note, you would include the interviewee's name, type of interview (e.g., "personal interview," "email interview"), and the date. Example: Jane Smith, personal interview by author, March 10, 2023.

For the author-date system, the reference list entry would be: Smith, Jane. Personal interview by author. March 10, 2023.

Formatting and Style Conventions

Beyond the mechanics of citation, the Chicago Manual of Style also dictates various formatting and stylistic conventions that contribute to a polished academic document. These include rules for capitalization, punctuation, numbers, and the use of abbreviations.

Punctuation and Capitalization

For example, when listing items, a comma is typically placed before the final "and" or "or." This helps to separate the last two items clearly, especially in complex lists.

Numbers and Abbreviations

The Manual offers detailed guidance on when to spell out numbers and when to use numerals. Generally, numbers below ten are spelled out, while those ten and above are presented as numerals. However, there are exceptions, especially when dealing with units of measurement or when numbers appear in a series with larger numbers. Similarly, the use of abbreviations is governed by specific rules to ensure clarity and avoid unnecessary jargon.

Common Citation Pitfalls and Solutions
