Formatting Conventions for Captions

Handling Large or Complex Figures

Large or complex figures, such as detailed schematics, intricate data visualizations, or extensive tables formatted as figures, require special consideration for Chicago Manual of Style figure caption placement. These may need to be formatted in landscape orientation to fit the page dimensions. The caption should still follow the figure, even if the figure is presented sideways.
