Understanding Forewords in Citation

Footnotes and Endnotes for Books with Forewords

When citing a book that includes a foreword, the citation needs to clearly indicate who wrote the foreword and who wrote the main text. This distinction is important because the primary intellectual ownership of the foreword rests with its author, separate from the main author.

Citing a Passage from the Main Text with a Foreword

When you are referencing material from the main body of the book, and the book happens to have a foreword, your footnote or endnote will primarily focus on the main author. However, if the foreword is particularly relevant to your point, or if you are quoting from it, a specific format is required. For general citations of the main text, you will list the main author first.

The standard format for a footnote or endnote when referring to the main author is:

- First Name Last Name, *Title of Book* (Place of Publication: Publisher, Year), page number(s).

For example:

- Jane Doe, *The History of the Renaissance* (Chicago: University of Chicago Press, 2020), 45.

Citing a Passage from the Foreword

If you are quoting directly from the foreword, or referring to a specific idea presented within it, you must attribute it to the foreword's author. The CMOS guidelines clearly delineate how to present this. The foreword author is treated as a distinct contributor to the overall publication. The citation will begin with the foreword author's name, followed by the indication that they wrote the foreword.

The format for citing a passage from the foreword is:

- Foreword author's First Name Last Name, foreword to *Title of Book*, by Main Author's First Name Last Name, page number(s). (Place of Publication: Publisher, Year).

Note the inclusion of "foreword to" and the main author's name as the author of the book itself. This clearly differentiates the roles of each individual within the publication.

An example would look like this:

- John Smith, foreword to *The Art of Diplomacy*, by Eleanor Vance, 7. (New York: Sterling Publishing, 2018).

It is crucial to be precise with this formatting to avoid any confusion regarding authorship and contribution.

When to Specify the Foreword Author

You should always specify the foreword author when you are directly quoting from the foreword or when you are making a point that is exclusively derived from the content of the foreword. If your discussion primarily engages with the main author's arguments, and the foreword is merely

introductory or contextual without contributing a distinct point you are referencing, you might not need to explicitly cite the foreword author in every instance, though it's generally good practice to acknowledge its presence if it significantly frames the work.

Bibliography Entries for Books with Forewords

The bibliography, or works cited list, provides a complete alphabetical listing of all the sources consulted and cited in your paper. The Chicago Manual of Style dictates a specific format for bibliography entries that includes forewords. The goal in the bibliography is to provide enough information for a reader to locate the source independently, and to clearly distinguish between the main author and the foreword author.

Structuring the Bibliography Entry for the Main Author

When the primary focus of your citation is the main body of the book, even if it has a foreword, the bibliography entry will prioritize the main author. The foreword is treated as a component of the larger work, but not the primary one unless you are specifically highlighting the foreword itself.

The standard bibliography entry for the main author is:

- Last Name, First Name. *Title of Book*. Place of Publication: Publisher, Year.

Structuring the Bibliography Entry for the Foreword Author

If your paper heavily relies on or discusses the foreword, or if you are citing it as a distinct contribution, you will create a bibliography entry that highlights the foreword author. This entry is structured differently from a standard book entry to emphasize the foreword's authorship.

The format for a bibliography entry where the foreword author is the primary focus is:

An example would be:

It is important to use the full page range of the foreword here, not just a single page number as you might in a footnote/endnote citation.

Consistency Between Footnotes/Endnotes and Bibliography

A crucial aspect of accurate citation is maintaining consistency between your in-text citations (footnotes/endnotes) and your bibliography. If you cite the foreword author in your footnotes/endnotes, you should also include a corresponding bibliography entry that reflects this attribution. Foreword by the Main Author

The foreword is still a separate piece, even if by the same author. You would typically note that the author wrote the foreword for their own work. The emphasis remains on clearly identifying the content you are referencing.

For a footnote/endnote, you might cite it as:

- First Name Last Name, foreword to *Title of Book*, by First Name Last Name, page number(s). (Place of Publication: Publisher, Year).

The bibliography entry would mirror this structure to avoid ambiguity.

Foreword in Translated Works

When citing a book that has been translated, and the translation includes a foreword, you need to

account for both the original author, the translator, and the foreword author. The Chicago Manual of Style provides specific guidance for these layered attributions. The foreword author is cited as usual, with their contribution clearly noted, and the translator is also acknowledged, often in the description of the book itself.

A common approach for a footnote/endnote would be:

- Foreword author's First Name Last Name, foreword to *Title of Book*, trans. Translator's First Name Last Name, page number(s). (Place of Publication: Publisher, Year).

The bibliography entry would follow a similar pattern, ensuring all key individuals and their roles are represented accurately.

Republished Forewords

If a foreword has been previously published elsewhere, for example, as an essay, and is now included in a book, you will need to cite both the original publication and its appearance within the book. This requires a slightly more complex citation to give credit to the original source of the foreword's content.

Your citation would typically include information about the original publication source as well as the book in which it appears. This ensures that readers can trace the origin of the foreword's ideas and give proper credit to its initial publication context.

Key Elements of a Chicago Style Citation for Forewords

Regardless of whether you are creating a footnote, endnote, or bibliography entry, certain key elements are consistently required when citing books with forewords in Chicago style. Attention to these details ensures accuracy and adherence to the manual's standards. These elements work together to paint a complete picture of the source and its contributors.

Essential Components for Footnotes/Endnotes

When citing a foreword in a footnote or endnote, the essential components are:

- The full name of the foreword author.
- The term "foreword to" to indicate their role.
- The title of the book, italicized.

A: If publication details are missing for the foreword, you should include all the information you can find. If the publication details for the main book are available, use those. For the foreword author, you would cite their name and the fact that they wrote the foreword to the book, followed by the book's title and author, and then whatever publication information is available. Omissions should be noted if they are unavoidable.
