Footnote and Endnote Citation of Books with Indexes

When using the notes-bibliography system, footnotes or endnotes are used to cite sources directly within the text. For citing a book that includes an index, the primary focus is on the book itself, rather than a separate citation of the index's existence. Subsequent Citations

After the first full citation of a book, subsequent references to the same work within your document are shortened. This shortened note typically includes the author's last name, a shortened version of the title (if necessary to distinguish it from other works by the same author), and the page number(s). For example: 2. Doe, *Art of Indexing*, 210.

If you cite the same source consecutively, you can use the term "Ibid." (meaning "in the same place") followed by the page number. If the page number is the same as the preceding citation, you can simply write "Ibid." For example, if your previous note cited page 210, a subsequent note referring to the same page would be: 3. Ibid. If it refers to a different page, say page 215, it would be: 4. Ibid., 215. This practice streamlines the citation process and avoids unnecessary repetition.

Bibliography Entries for Books with Indexes

The bibliography, located at the end of a document, provides a comprehensive list of all sources cited. For books, the bibliography entry for a work with an index follows a format similar to the footnote, but with key differences in author name presentation and punctuation. When citing specific editions or reprints, this information should be clearly indicated. For example, if you are using the second edition, you would include "2nd ed." after the title. example, in a footnote: 6. John Miller, "The Evolution of Indexes," in *Essays on Bibliographic Practice*, ed. Michael Smith (New York: Academic Press, 2021), 78. The bibliography entry would follow a similar structure.

Multiple Editions and Reprints

When a book has gone through multiple editions, it is crucial to cite the specific edition you consulted. This is indicated by adding the edition number (e.g., 2nd ed., rev. ed.) after the book's title, before the publication information. For example: 7. Eleanor Vance, *The History of Print*, 3rd ed.
