In a note:

In a reference list (author-date system):

Smith, John. 2022. "Understanding Citation Styles." *Journal of Academic Writing* 15, no. 3: 110–25.

Websites and Online Articles

Citing online content requires careful attention to detail, especially concerning the availability of stable links. Include author (if known), title of the specific page or article, name of the website (if different from the article title), publication or last updated date, and the URL or DOI. If no author or publication date is evident, use the most relevant information available.

In a note:

3. "Global Climate Trends," National Oceanic and Atmospheric Administration, accessed May 15, 2023, <https://www.noaa.gov/climate>.

In a bibliography:

In-Text Citations in Chicago Style

How you indicate a citation within the body of your text depends on the system you are using.

Notes-Bibliography System In-Text Citations

In this system, a superscript Arabic numeral is placed after the relevant passage, punctuation mark, or sentence. This number corresponds to a note at the bottom of the page (footnote) or at the end of the chapter or document (endnote).

The first time a source is cited, the note includes full bibliographic information. Subsequent citations of the same source can be shortened, often using just the author's last name and page number, or the term "ibid." (for the immediately preceding source) if applicable.

Author-Date System In-Text Citations

The author-date system uses parenthetical citations within the text. The standard format is (AuthorLastName Year, PageNumber).

For example: The study indicated a significant correlation (Smith 2020, 55).

If the author's name is mentioned in the text, the year and page number are enclosed in parentheses: As Smith (2020) argues, the findings are significant (55).

Formatting the Bibliography or Reference List

The end matter of your Chicago-style paper plays a crucial role in providing readers with access to your sources.

The Bibliography (Notes-Bibliography System)

The bibliography is an alphabetical list of all sources consulted or cited in the paper. Entries are typically double-spaced, with a hanging indent for all lines after the first line of each entry. Author names are listed last name first. Titles of books and journals are italicized, while article titles are enclosed in quotation marks.

The Reference List (Author-Date System)

The reference list in the author-date system is also an alphabetical list of all sources cited in the text. The formatting is similar to the bibliography, with entries alphabetized by author's last name. The primary difference is the placement of the year: it follows the author's name in parentheses.

Example entry in a reference list:

Smith, John. 2020. *The Impact of Technology on Education*. New York: Academic Press.
