Understanding E-book Citations in Chicago Style

The Core Components of an E-book Citation

Regardless of whether you are using the Notes and Bibliography system or the Author-Date system, certain core components are essential for a complete e-book citation in Chicago style. Notes and Bibliography System for E-books

The Notes and Bibliography system is the preferred method for many humanities and some social science disciplines. When citing an e-book within this system, the goal is to provide detailed information in the footnotes or endnotes to uniquely identify the source, and then to consolidate this information in the bibliography.

Footnote/Endnote Structure

A typical footnote or endnote for an e-book will include:

- Author's First Name Last Name
- *Title of E-book: Subtitle*
- (Publisher, Year), page number (if applicable).
- DOI or URL

For example: Jane Doe, *The Digital Age: Navigating New Technologies* (TechPress, 2023), 45. <https://doi.org/xxxxxxxxx>.

Bibliography Entry Structure

The bibliography entry is similar but follows a slightly different punctuation and order, prioritizing the author's last name first for alphabetical sorting:

- Author's Last Name, First Name. *Title of E-book: Subtitle*. Publisher, Year. DOI or URL.

For example: Doe, Jane. *The Digital Age: Navigating New Technologies*. TechPress, 2023. <https://doi.org/xxxxxxxxx>.

Page Numbers and Locators

Because e-books often lack stable pagination, CMOS allows for flexibility. If the e-book has stable page numbers (sometimes indicated by a PDF format or specific e-reader features), these should be used. If stable page numbers are unavailable, you may cite chapter numbers, section numbers, or even

paragraphs, depending on what is most helpful for your reader to locate the information. Consistency in your chosen method throughout your work is key.

Author-Date System for E-books

The Author-Date system is more common in the natural and social sciences. It provides a concise in-text citation that allows readers to quickly identify the source and then find the full details in the reference list at the end of the work.

In-Text Citation Format

The in-text citation for an e-book using the Author-Date system typically includes the author's last name and the year of publication in parentheses:

(Author's Last Name Year, page number if available)

For example: (Doe 2023, 45).

If the author's name is mentioned in the sentence, only the year and page number are needed in parentheses: (2023, 45).

Reference List Entry Format

The reference list entry in the Author-Date system provides the full bibliographic details. The structure is similar to the bibliography entry in the Notes and Bibliography system, but the date is placed immediately after the author's name.

- Author's Last Name, First Name. Year. *Title of E-book: Subtitle*. Publisher. DOI or URL.

For example: Doe, Jane. 2023. *The Digital Age: Navigating New Technologies*. TechPress. <https://doi.org/xxxxxxx>.

Locating Specific Passages

When citing an e-book without stable page numbers, the author-date system also permits the use of alternative locators. This might include chapter numbers or specific section headings. - Author Last Name, First Name. Year. *Title of E-book*. Publisher. DOI.

E-books Without DOIs

If an e-book does not have a DOI, you will typically provide a URL to the source. It's best to use a stable URL, such as from a database or a reputable academic repository, rather than a temporary or personal download link. If the e-book is accessed through a specific platform like Kindle or Google Books, you may sometimes include the platform name, but CMOS often favors a direct URL to the file or its landing page.

E-books from Online Databases and E-readers

When citing an e-book accessed through a subscription database (like JSTOR or Project MUSE) or a specific e-reader platform (like Kindle or Kobo), the approach can vary. CMOS generally prioritizes the most stable locator. If a DOI is available, use it. If not, a direct URL to the e-book on the platform is preferred. For e-readers, if the e-book is widely available across platforms, citing the publisher and publication date is often sufficient, especially if you are not referencing specific page numbers unique to that device's rendering. However, if the platform offers specific locators that aid in finding the passage, consider including them.

Identifying Key E-book Information for Citations

Accurately identifying the necessary information for your e-book citations is a critical first step. This often requires a careful examination of the e-book's front matter and copyright pages, as well as the digital interface itself.

Where to Find Publication Details
