BY ADHERING TO THE CMOS, AUTHORS CAN CREATE A STABLE AND RELIABLE NARRATIVE PERSPECTIVE, WHICH IS ESSENTIAL FOR READER IMMERSION AND TRUST.

FORMATTING AND MANUSCRIPT PREPARATION
