THIS SYSTEM IS PARTICULARLY USEFUL FOR IN-DEPTH CRITICAL ESSAYS OR ANALYSES WHERE FREQUENT REFERENCING IS REQUIRED. THE DETAILED INFORMATION PROVIDED IN THE NOTES ALLOWS READERS TO TRACE THE AUTHOR'S SOURCES WITHOUT DISRUPTING THE FLOW OF THE MAIN TEXT.

THE AUTHOR-DATE SYSTEM FOR LITERARY WEBSITES

THE AUTHOR-DATE SYSTEM USES PARENTHETICAL CITATIONS WITHIN THE TEXT (E.G., (SMITH 2023, 45)) FOLLOWED BY A REFERENCE LIST. THE KEY IS TO ENSURE THAT THE IN-TEXT CITATIONS DIRECTLY CORRESPOND TO THE ENTRIES IN THE REFERENCE LIST, WHICH SHOULD BE EASILY ACCESSIBLE.

FORMATTING BIBLIOGRAPHIES AND WORKS CITED

REGARDLESS OF THE CHOSEN SYSTEM, THE BIBLIOGRAPHY OR REFERENCE LIST MUST BE METICULOUSLY FORMATTED ACCORDING TO CMOS GUIDELINES.
