Understanding the Core Principles of CMOS Online Book Citations

Author and Title Information

The author's name is typically presented in the format of Last Name, First Name. For multiple authors, Chicago follows specific conventions for listing them. The title of the book itself is always italicized to distinguish it as a standalone work. This includes any subtitles, which are also italicized and separated from the main title by a colon.

Publication Details and Digital Identifiers

When citing an online book that has a print equivalent, you should aim to include the original publication details as found on the print version. This often involves listing the place of publication, publisher, and year. However, the most critical element for online resources is the Digital Object Identifier (DOI) if one is available. A DOI is a persistent identifier that ensures the link remains active even if the website address changes. If a DOI is not present, a stable URL is the next best option.

Considerations for Accessibility

The primary aim of including a URL or DOI is to facilitate easy access for your readers. Therefore, it's recommended to use the most direct and stable link possible. Avoid links that require complex logins or are prone to expiring. If the e-book is only available in digital form and does not have a print counterpart, the citation would focus on its electronic nature.

Bibliography Entry Format for E-books

The corresponding bibliography entry aims for a slightly more condensed yet complete presentation, allowing for quick identification of the source. The author's last name is placed first.

Author Last Name, First Name. *Title of Book*. Place of Publication: Publisher, Year. Accessed Month Day, Year. URL or DOI.

Reference List Entry for E-books

The reference list entry for an e-book in the author-date system closely resembles the bibliography entry in the notes-and-bibliography system, with the primary difference being the placement and format of the in-text citation elements.

Author Last Name, First Name. Year. *Title of Book*. Place of Publication: Publisher. Accessed Month Day, Year. URL or DOI.

For example:

Doe, Jane. 2022. *The Digital Age of Scholarship*. New York: Academic Press. Accessed October 26, 2023. <https://doi.org/10.1000/xyz123>.

It is crucial to ensure that the information in the reference list entry directly corresponds to the information used in the in-text citations to maintain consistency and facilitate ease of use for your readers.

For example:

Smith, John. *Foundations of Digital Research*. London: University Press, 2021. Accessed October 26, 2023. JSTOR. <https://www.jstor.org/stable/12345678>.

Works Without a Traditional Publication Date or Publisher

Some online books, especially those found on academic or personal websites, may not have a clear publisher or publication date. In these instances, CMOS provides guidance on how to proceed.

If a publication date is missing, use "n.d." (no date). If a publisher is absent, you may omit it, but try to provide as much other identifying information as possible. For documents published on an organizational website, you might cite the organization as the author.

Edited Volumes and Contributions to Online Collections

Citing an individual chapter or essay within an edited online volume requires a slightly more complex structure, distinguishing the contribution from the overall work.

The format would typically include the author of the chapter, the chapter title, the editor(s) of the volume, the overall title of the book (italicized), publication details, and then the access information.

- Chapter Author Last Name, First Name. "Chapter Title." In *Title of Edited Book*, edited by Editor First Name Last Name, Page range. Place of Publication: Publisher, Year. Accessed Month Day, Year. URL or DOI.

This detailed approach ensures that even the most complex online sourcing scenarios can be addressed with clarity and accuracy, upholding the standards of academic integrity.
