Understanding Chicago Style for Online Journals

The Chicago Manual of Style (CMOS) is a widely adopted style guide in the humanities and social sciences, providing comprehensive rules for manuscript preparation and citation. Journal Title and Publication Details

A DOI is a persistent identifier assigned to a digital object, ensuring that the link remains active even if the original URL changes. Therefore, whenever available, a DOI is the preferred method for indicating online access. If a DOI is not available, a stable, direct URL to the article is used.

When using a URL, it's important to provide the most direct link possible. Avoid linking to a journal's homepage or a search results page. Instead, aim for the permalink to the specific article. CMOS guidelines suggest including the date of access when citing online resources, especially if there is a possibility of the content changing over time. This is typically presented as "accessed [Month Day, Year]."

Formatting Author Names

In the bibliography, author names are listed with the last name first, followed by the first name. For example, "Smith, John." If there are multiple authors, the first author's name is inverted, and subsequent authors' names are listed in normal order (First Name Last Name). For three or more authors, CMOS generally recommends listing the first author followed by "et al." in the notes, but in the bibliography, all authors' names may be listed, or the first author followed by "et al." depending on the specific edition of CMOS and publisher preferences.

Citing Articles with No Author

When an article lacks a specific author, the citation begins with the title of the article. The article title is enclosed in quotation marks and followed by the journal title, volume, issue, date, and access information, just as it would be if an author were listed. The absence of an author does not diminish the need for complete bibliographic information.

Citing Articles with Multiple Authors

For articles with two or three authors, both author names are included in the bibliography, with the first name inverted. For articles with four or more authors, the Chicago Manual of Style, 17th edition, suggests listing the first author's name followed by "et al." in both notes and the bibliography. This helps to keep bibliographies concise while still providing adequate attribution.

Handling Different Publication Dates

Online journals may have more frequent publication schedules than traditional print journals, sometimes publishing articles as they are completed rather than in discrete issues. CMOS addresses this by allowing for the inclusion of specific publication dates if available, in addition to the volume and issue numbers. If only a year is available, that is used. The goal is to provide the most precise date information possible.

When a Journal is Only Available Online

For journals that exist solely in digital format, the citation structure is similar to that for print journals that have an online presence, but the emphasis on online access information becomes even more critical. Since there is no print counterpart, the URL or DOI is the sole means of locating the publication. The absence of a physical copy means the digital locator is indispensable for verification.

Citations for Articles Found in Databases

Many online journal articles are accessed through academic databases like JSTOR, Project MUSE, or EBSCOhost. When citing an article found in a database, you should still include the journal title, volume, issue, date, and DOI if available. If a DOI is not provided by the database, then a URL is used, typically pointing to the database's landing page for that article. However, CMOS prioritizes DOIs when they are present, even if the article is accessed via a database.

Footnotes and Endnotes vs. Bibliography Entries

In the notes-bibliography system, footnotes or endnotes provide immediate citation for specific points within the text. The first citation of a source in a note is typically longer and more detailed, including all relevant publication information and access details. Subsequent citations of the same source are usually shortened, often just including the author's last name, a shortened title, and page number or relevant access information.

The bibliography entry, on the other hand, is a more comprehensive listing of all sources consulted, presented in alphabetical order by the author's last name. Bibliography entries for online journal articles follow the general format described, providing all necessary information for the reader to locate the source independently. The bibliography entry is generally more complete than the first note citation.
