Understanding the Chicago Manual of Style for Poetry

The Chicago Manual of Style (CMOS) is a widely respected style guide used in many academic disciplines, particularly in the humanities. When it comes to citing literature, especially poetry, CMOS offers detailed instructions to

ensure clarity, consistency, and accuracy. The manual provides two primary citation systems: the notes-and-bibliography system and the author-date system. Citing an Individual Poem in a Collection

Citing a Poem from a Standalone Volume

If a poem is published in a standalone volume dedicated solely to that poem or a specific sequence of poems, the citation is more straightforward. The focus is on the poet and the specific volume. The note would include the poem's title (if it's a distinct poem within a larger work) and the title of the standalone volume, along with publication details.

For example, citing a section from Whitman's *Leaves of Grass*: "Song of Myself," in Walt Whitman, *Leaves of Grass* (New York: Penguin Books, 1999), 28. The bibliography entry would simply list Whitman's *Leaves of Grass* with its publication details.

Using Line Numbers vs. Page Numbers in Poetry Citations

A crucial aspect of citing poetry is determining whether to use line numbers or page numbers. For extensively studied poems or those published in editions that consistently number lines, line numbers are often preferred as they provide a stable reference point across different editions. Many classic poems, especially those with established critical traditions, are frequently cited by line number. However, CMOS advises using page numbers as the primary reference unless line numbering is clearly established and consistently used by the edition you are referencing.

When referring to line numbers, they are typically indicated after the page number or in place of it, depending on the convention of the edition and the specific needs of your analysis. For instance, a citation might look like: "The Raven," by Edgar Allan Poe, in *The Complete Tales and Poems of Edgar*

Allan Poe (New York: Vintage Books, 1992), 204, lines 1–4. Some scholars opt for a format that prioritizes line numbers if they are consistently present and essential for the argument, such as: "The Raven," lines 1–4, in Poe, *Complete Tales and Poems*, 204. Always be consistent within your document.

The Author-Date System for Poetry Citations

The author-date system, often used in the social sciences and some natural sciences, is also a valid option for citing poetry in academic writing, especially if it is the required style for a particular course or journal. This system places parenthetical citations within the text, typically consisting of the author's last name and the publication year, followed by page or line numbers. A reference list at the end of the work provides full publication details.

Author-Date Citations for Poems

In the author-date system, a parenthetical citation for a poem would include the author's last name, the year of publication of the collection or anthology you are using, and the page or line number. For instance, if you are quoting from Dickinson's "Because I could not stop for Death" from the Norton Anthology of Poetry published in 2005:

This might appear in your text as: Emily Dickinson's speaker recognizes that "He kindly stopped for me – / The Carriage held but just Ourselves – / And Immortality" (Dickinson 2005, 612). The corresponding entry in your reference list would provide full bibliographic information for the anthology.

Author-Date Citations for Poetry Collections

When citing multiple poems from the same collection by a single author, the parenthetical citations will refer to that author and the year of the collection. The emphasis is on directing the reader to the specific work and edition. For example, if referencing several poems from T.S. Eliot's *The Waste Land and Other Poems* (Norton, 2001):

A quote might be cited as (Eliot 2001, 12). The reference list entry would detail Eliot's *The Waste Land and Other Poems*, including the publisher and year.

Key Elements in Poetry Citations

Author and Poem Title

Citing Poetry from Online Sources

CMOS provides guidelines for citing digital resources. When citing poetry online, include as much bibliographic information as is available (author, poem title, collection title if applicable, website name, publisher, date of publication or last update, and a URL or DOI). If the poem is from a reputable online literary journal or archive, treat it similarly to a print publication, but always include the access date if the source is likely to change.
