Social Media and Multimedia

For multimedia like videos or podcasts, include the creator, title, platform, date, and URL.

• Social Media Post:

- Author (Username or Real Name)

- Name of the Social Media Platform
- Date of the post
- URL

• Video/Podcast:

- Creator (Individual or Organization)

- Title of the video/podcast episode
- Name of the platform (e.g., YouTube, Spotify)
- Date of publication or upload
- URL

The challenge with social media is that content can be ephemeral. Therefore, including an access date is highly recommended.

Handling Missing Information in Website Citations

One of the most common difficulties when citing online sources is the absence of crucial information, such as an author or a publication date. CMOS provides guidance on how to handle these situations gracefully, ensuring your citations remain informative even when incomplete.

If no author is listed, begin the citation with the title of the article or page. If there is no publication date, use the abbreviation "n.d." (no date). Uniform Resource Locators (URLs) are the direct addresses to web pages.
