These elements allow readers to identify and locate the source with precision. When citing handbooks, specific details about the handbook itself become paramount.

Key Bibliographic Information

The core components of any Chicago style citation, including those for handbooks, generally include:

- Author(s) or Editor(s)
- Title of the work (and subtitle, if any)
- Publisher
- Place of publication
- Year of publication
- Page number(s) (for specific references)
- Edition information (if not the first edition)

Edition and Publication Details for Handbooks

Page numbers are generally omitted from bibliography entries unless the entire work is a collection of separately paginated sections.

The corresponding bibliography entry for the example above would be:

- Wiles, Charles P. *The Handbook of Legal Terminology*. New York: Legal Press, 2019.

Notice the reversal of the author's name and the placement of the period after the author's name, which are standard for bibliography entries in Chicago style.

Citing Handbooks Using the Author-Date System

The author-date system simplifies in-text citations but still requires a comprehensive reference list. This system prioritizes efficiency and immediate source attribution.

Formatting In-Text Citations

In-text citations in the author-date system are concise and appear directly within the text, usually in parentheses. They consist of the author's last name and the year of publication. If you are referencing a specific page, that number is also included.

An example of an in-text citation for a handbook would be:

Formatting Reference List Entries

The reference list, found at the end of the document, contains entries for all sources cited in the text. For handbooks, the format closely resembles the bibliography entry in the notes and bibliography system, with the author's last name first, followed by the publication year in parentheses. The title of the handbook is italicized, followed by the publisher and place of publication. Page numbers are typically not included in the reference list entry itself unless the handbook is a collection or edited volume where individual contributions are itemized.

The reference list entry for the handbook would be:

- Wiles, Charles P. 2019. *The Handbook of Legal Terminology*. New York: Legal Press.

A key distinction here is the inclusion of the publication year immediately after the author's name and before the title, separated by a period.

- The University of Chicago Press. 2017. *The Chicago Manual of Style*. 17th ed. Chicago: University of Chicago Press.

Citing Handbooks with No Author or Editor

Some handbooks are published by organizations or committees without a clearly designated author or editor. In such cases, the organization name is used as the author. If the organization name is also the publisher, you can omit the publisher's name and use the organization's name as the author. For example, if an association publishes a handbook and the association's name is also the publisher, the entry would begin with the association's name.

For instance, if the "American Medical Association" published a handbook titled "AMA Style Guide," the entry would begin with "American Medical Association." The specific treatment can vary slightly, so consulting the latest CMOS edition or adhering to specific journal requirements is always advised.

Handling Different Editions and Printings

As mentioned, differentiating between editions is vital. However, also distinguishing between editions and printings is important for scholarly rigor.
