HISTORICAL SIGNIFICANCE AND EVOLUTION

THE GENESIS OF THE CHICAGO MANUAL OF STYLE (CMOS) CAN BE TRACED BACK TO THE EARLY 20TH CENTURY, A PERIOD OF BURGEONING GROWTH AND INCREASING STANDARDIZATION IN THE AMERICAN PUBLISHING INDUSTRY. THE MLA (MODERN LANGUAGE ASSOCIATION) STYLE IS PRIMARILY USED IN THE

HUMANITIES, PARTICULARLY FOR LITERATURE AND THE ARTS, WITH A STRONG EMPHASIS ON TEXTUAL ANALYSIS AND LITERARY CRITICISM. CMOS OFFERS MORE FLEXIBILITY IN CERTAIN AREAS, ESPECIALLY REGARDING CITATION, WITH ITS TWO DISTINCT SYSTEMS.

Q: HOW DOES THE CHICAGO MANUAL OF STYLE ADDRESS THE CHALLENGES OF DIGITAL PUBLISHING?
