Understanding the Chicago Manual of Style for Journal Citations

Articles with Multiple Authors

For articles with four or more authors, CMOS generally advises listing only the first author's name followed by "et al." in the notes and bibliography (notes-bibliography system) or in the in-text citations (author-date system). The reference list in the author-date system may list all authors or use "et al." depending on the specific publication's preference.
