In the Author-Date system: (Doe and Roe 2021, 112). Reference list: Doe, Jane, and Richard Roe. *Advanced Citation Techniques*. New York: Academic Publishers, 2021.

For three or more authors, the first note or in-text citation lists all authors, but subsequent notes or reference list entries use the first author's name followed by "et al."

Citing Journal Articles in Chicago Style

Journal articles are vital for tracking current scholarship. Correctly citing them in your Chicago manual of style quick guide for citation style implementation is essential.

When a Digital Object Identifier (DOI) is available, it is preferred over a URL. Notes and Bibliography system, first note: 4. David Lee, "Trends in Scholarly Publishing," *Academic Research Quarterly* 15, no. 1 (2022): 32, doi:10.1000/jrq.2022.15.1.32.

Bibliography entry: Lee, David. "Trends in Scholarly Publishing." *Academic Research Quarterly* 15, no. 1 (2022): 30-45. doi:10.1000/jrq.2022.15.1.32.

Author-Date system, in-text citation: (Lee 2022, 32). Reference list entry is the same.

Citing Websites and Online Sources

The proliferation of online information necessitates clear guidelines for web citations, a key aspect of any Chicago manual of style quick guide for citation style.

Webpages

Notes and Bibliography system, first note: 5. "About Us," Wikipedia, last modified October 26, 2023, https://en.wikipedia.org/wiki/Chicago_Manual_of_Style.

Author-Date system, in-text citation: (Chen 2023). Reference list entry is the same.

In-Text Citations: Notes and Bibliography System

In the Notes and Bibliography system, in-text citations are handled through superscript numbers. A Chicago manual of style quick guide for citation style emphasizes the placement and formatting of these numbers.

Each number corresponds to a note, either a footnote at the bottom of the page or an endnote at the end of the document. The first time a source is cited, the note contains full bibliographic information.
