The in-text citation might be (Chicago Style Blog, n.d.) if no date is available, or (Chicago Style Blog 2023) if a date is discernible. The reference list entry would be:

Chicago Style Blog. 2023. "About Citation Standards." Accessed June 15, 2023. <https://www.chicagostyle.org/about>.

Citing Other Source Types

Beyond books and articles, Chicago manual of style references extend to a wide array of other materials. Each has specific formatting nuances to ensure clarity and completeness.

Citing Edited Collections and Chapters

These academic works require specific details about the institution and degree.

- **Notes-Bibliography:** Author, "Title of Dissertation" (Ph.D. diss., University Name, Year).
- **Author-Date:** Author. Year. "Title of Dissertation." Ph.D. diss., University Name.

In-Text Citations in Chicago Style

In-text citations are the brief references within your manuscript that point readers to your full source list. Correctly implementing these is crucial for both Chicago manual of style references and academic integrity.

Notes-Bibliography In-Text Citations
