Journal Articles

Journal articles are cited with the author's name, article title (in quotation marks), journal title (italicized), volume and issue numbers, publication year, and page numbers. In a note: 4. Emily Carter, "The Impact of Industrial Decline on Rural Communities," *Journal of Social Studies* 42, no. 3 (2019): 301. In the bibliography: Carter, Emily. "The Impact of Industrial Decline on Rural Communities." *Journal of Social*

Studies 42, no. 3 (2019): 295-315. Ensure that volume and issue numbers are presented correctly as per CMOS guidelines.

Handling Edited Volumes and Multi-Author Works
