The Chicago Manual of Style: An Overview

Footnotes and Endnotes

In the notes-bibliography system, footnotes appear at the bottom of the page on which the reference is made, while endnotes are gathered at the end of the document, chapter, or book. Both serve the same purpose: to provide the citation information for a specific point in the text. The inclusion of a superscript numeral after the cited information in the main text signals the presence of a corresponding note.

The first time a source is cited, the note should include all essential publication details: author's full name, title of the work, publication information (place, publisher, year), and page number(s). Subsequent citations of the same source can be significantly abbreviated. Common abbreviations include the author's last name, a shortened title, and the page number. For direct quotes, the specific page number is crucial.

Bibliography Entries

Reference List Entries

The reference list, appearing at the end of the document in the author-date system, contains full bibliographic information for every source cited in the text. Each entry begins with the author's last name followed by their first name, then the year of publication, and subsequently other relevant publication details.

The structure of reference list entries varies depending on the type of source. However, the consistent order of author, date, title, and publication information ensures that readers can easily locate the original sources. Alphabetical order by author's last name is the standard for the entire reference list. This systematic organization is critical for academic rigor.

When citing specific pages for direct quotes or paraphrased ideas, the page number is always included, for instance (Doe 2022, 75) in the author-date system or with the page number in the note for the notes-bibliography system.

Journal Article Citations

Journal articles are commonly cited in scholarly work, and Chicago style provides specific guidelines for them. For the notes-bibliography system, the initial note typically includes the author's full name, the title of the article (in quotation marks), the title of the journal (italicized), the volume and issue numbers, the year of publication, and the page numbers of the article. For example, a footnote might read: John Smith, "The Evolution of Citation Practices," *Journal of Academic Writing* 15, no. 2 (2021): 112-130. Subsequent notes would be abbreviated.

In the author-date system, the reference list entry would be: Smith, John. 2021. "The Evolution of Citation Practices." *Journal of Academic Writing* 15, no. 2: 112-130. The in-text citation would be (Smith 2021). It is crucial to include the specific page number when quoting or referencing a particular passage from the article.

Website and Online Resource Citations

Citing online resources, including websites, has become increasingly important in scholarly research. The Chicago Manual of Style offers guidance for these dynamic sources. For notes-bibliography, a citation might include the author or organization responsible, the title of the specific page or document, the name of the website, the publication or last updated date (if available), and the URL. A DOI (Digital Object Identifier) should be included if available, as it provides a persistent link. For example: National Archives and Records Administration, "Declaration of Independence," accessed July 15, 2023, <https://www.archives.gov/founding-docs/declaration-transcript>. Note that direct access dates are generally less emphasized now in favor of stable links like DOIs.

In the author-date system, the reference list entry would be: National Archives and Records Administration. n.d. "Declaration of Independence." Accessed July 15, 2023.

<https://www.archives.gov/founding-docs/declaration-transcript>. The in-text citation would typically be just the author or organization, and if no date is available, "n.d." (no date) is used in the reference list. The Chicago Manual of Style also strongly encourages the use of stable URLs or DOIs whenever possible for online resources.

Common Citation Challenges in Chicago Style
