Three or More Authors

Only the first author's name is provided in the reference list, followed by "et al." This convention keeps the reference list concise while still acknowledging the primary author.

- **Notes-Bibliography Format:** Last Name, First Name, et al. *Title of Book*. City of Publication: Publisher, Year of Publication.
- **Author-Date Format:** Last Name, First Name, et al. Year of Publication. *Title of Book*. City of Publication: Publisher.
