For a note: 2. Jane Doe, "The Impact of Technology," *Journal of Modern Studies* 25, no. 3 (2019): 210. The bibliography entry: Doe, Jane. "The Impact of Technology." *Journal of Modern Studies* 25,

no. 3 (2019): 205–230. Page numbers for notes refer to the specific location within the article, while the bibliography entry includes the full page range of the article.

Online Sources

Citing online sources requires careful attention to detail, as URLs and access dates are often included. For a webpage, a note might look like: 3. “About Us,” Example Website, last modified March 15, 2023, <https://www.example.com/about>. The corresponding bibliography entry would be: “About Us.” Example Website. Last modified March 15, 2023. <https://www.example.com/about>. It is important to check journal guidelines regarding the necessity of including URLs and access dates for online sources, as practices can vary.

The Role of CMOS in Peer Review and Publication
