Understanding the Chicago Style Author-Date System

For websites, it may include the website name, the specific page title, and the URL. For edited books, the editor's name(s) would be included, and for book chapters, the chapter title and page range, along with the book title and editor.

Books

Journal Articles

Journal articles are a cornerstone of academic research. The author-date format for these includes the author(s), publication year, article title, journal title, volume, issue number, and page range. The journal title is italicized, and the article title is in quotation marks.

- Single Author: Last Name, First Name. Year. "Article Title." *Journal Title* Volume (Issue): Page numbers.
- Example: Williams, Robert. 2021. "The Impact of Technology on Learning." *Journal of Educational Studies* 45 (2): 112-130.
- Article with DOI: Last Name, First Name. Year. "Article Title." *Journal Title* Volume (Issue): Page numbers. doi:XX.XXXX/YYYYYY.
- Example: Garcia, Maria. 2022. "Climate Change Adaptation Strategies." *Environmental Science Journal* 50 (3): 201-225. doi:10.1080/00139157.2022.2056789.

Websites and Web Pages

Citing online sources requires careful attention to identifying the author (if any), the date of publication or last update, the title of the page, the website name, and the URL. If an author is not listed, start with the title of the specific page.

- Author and Date: Last Name, First Name. Year. "Title of Web Page." Name of Website. Accessed Month Day, Year. URL.
- Example: Davis, Lisa. 2023. "Understanding AI Ethics." Future Tech Today. Accessed January 15, 2024. <https://www.futuretechtoday.com/ai-ethics>.
- No Author, Date: "Title of Web Page." Year. Name of Website. Accessed Month Day, Year. URL.
- Example: "Global Economic Trends." 2022. World Finance Online. Accessed February 20, 2024. <https://www.worldfinanceonline.com/economic-trends>.

Formatting In-Text Citations in Chicago Style Author-Date

In-text citations are the brief references placed within the body of your research paper that point readers to the full bibliographic entries. In the Chicago author-date system, these citations typically include the author's last name and the year of publication. The purpose is to concisely attribute information without disrupting the flow of your writing.

The placement of these parenthetical citations is crucial. They should generally appear at the end of a sentence or clause that contains the borrowed information, before the period. If you are directly quoting, the page number must also be included. When paraphrasing or summarizing, the page number is often omitted, but it is good practice to include it if it helps the reader locate the specific idea within a longer work.

Direct Quotations

When using a direct quote, you must include the author's last name, the year of publication, and the page number(s) from which the quote was taken. The page number should be preceded by "p." for a single page or "pp." for a range of pages.

- Example (at end of sentence): The study found that "participants demonstrated a significant improvement in comprehension" (Smith 2020, 15).
- Example (integrating author into sentence): Smith (2020) noted that "participants demonstrated a significant improvement in comprehension" (15).

Paraphrasing or Summarizing

When you are paraphrasing or summarizing an idea from a source, the in-text citation includes the author's last name and the year of publication. Page numbers are generally not required for paraphrased material, though they can be helpful for longer works.

- Example: Research indicates that the historical development of citation styles has been complex and varied (Jones, Lee, and Chen 2018).
- Example (integrating author into sentence): Jones, Lee, and Chen (2018) discuss the complex and varied historical development of citation styles.

Citing Multiple Works

If you are citing multiple works within a single parenthetical citation, list them in alphabetical order by author's last name, separated by semicolons.

- Example: Previous studies have explored various pedagogical approaches (Brown 2019; Garcia 2022; Williams 2021).

Citing More Complex and Less Common Sources

- Example: World Health Organization. 2021. *Global Health Trends Report*. Geneva: WHO Press.
- Government Document: Name of Government. Name of Agency. Year. *Title of Document*. Series information (if applicable). Publication location: Publisher.
- Example: United States. Department of Health and Human Services. 2022. *National Health Survey Findings*. Washington, DC: Government Printing Office.

Films and Videos

Citing visual media involves identifying the director, title, production company, and year. For documentaries, the narrator or primary subjects might also be included.

- Film: Director, First Name Last Name, dir. Year. *Title of Film*. Production Company.
- Example: Nolan, Christopher, dir. 2010. *Inception*. Warner Bros. Pictures.
- Online Video: Creator Last Name, First Name, or Name of Organization. Year. "Title of Video." Platform Name. Accessed Month Day, Year. URL.
- Example: TED. 2015. "Your Body Language May Be Holding You Back." YouTube. Accessed March 10, 2024. https://www.youtube.com/watch?v=Ks-_Mh1QhMc.

Interviews

For interviews, whether published or conducted personally, it's important to note the interviewee, the interviewer (if applicable), the date, and the context of the interview.

- Personal Interview: Interviewee Last Name, First Name. Year. Personal interview by Interviewer First Name Last Name. Month Day.
- Example: Curie, Marie. 1910. Personal interview by Pierre Dubois. November 5.
- Published Interview: Interviewee Last Name, First Name. Year. Interview by Interviewer First Name Last Name. *Publication Title*, Month Day.
- Example: Einstein, Albert. 1950. Interview by George Harrison. *Life Magazine*, April 10.
