When citing works with multiple authors, the Chicago author-date system has specific guidelines to ensure clarity and consistency:

- **Two Authors:** List both authors. The first author is listed as Last Name, First Name. The second author is listed as First Name Last Name.
- **Three or More Authors:** List only the first author's name, followed by "et al." (an abbreviation meaning "and others"). The first author is presented as Last Name, First Name.

This approach simplifies the bibliographic entry while still pointing readers to the primary author and indicating that other contributors exist. It's crucial to note that in the in-text citations for works with three or more authors, only the first author's name followed by "et al." and the year is used.

Citing Books in an Author-Date Bibliography

Books are a fundamental source type in academic writing, and their citation in a Chicago author-date bibliography requires attention to detail regarding author, title, publication date, and publisher information. The structure provides a clear roadmap for identifying specific editions and printings.

Basic Book Entry

Edited Books

When citing a book that has been edited rather than authored by a single individual, the editor's name(s) take the place of the author's name(s) in the entry. The role of the editor is usually indicated with "ed." for one editor or "eds." for multiple editors.

- Editor Last Name, First Name, ed. Year. *Book Title: Subtitle*. Place of Publication: Publisher.
- For multiple editors: Editor Last Name, First Name, and Editor Second Last Name, First Name, eds. Year. *Book Title: Subtitle*. Place of Publication: Publisher.

Books with More Than One Edition

If you are citing a specific edition of a book other than the first, you must indicate the edition number. This is crucial for ensuring readers find the exact version you consulted, as content can vary significantly between editions.

- Author Last Name, First Name. Year. *Book Title: Subtitle*. Edition Number ed. Place of Publication: Publisher.

For instance: Davis, Emily. 2021. *Modern Literary Theory*. 3rd ed. London: Routledge.

Citing Journal Articles in an Author-Date Bibliography

Journal articles are a cornerstone of scholarly communication. Citing them correctly in the Chicago author-date bibliography requires precision in listing the author, publication year, article title, journal title, volume, issue, and page numbers.

- Author Last Name, First Name. Year. "Article Title: Subtitle." *Journal Title* Volume (Issue): Page numbers. Accessed Month Day, Year. URL.

Articles without Page Numbers (e.g., Online-Only Journals)

Some online journals may not have traditional page numbers. In such cases, the entry should reflect the article's designation or section if one exists. The primary goal remains to help the reader locate the specific content.

Citing Websites and Web Pages in an Author-Date Bibliography

The proliferation of online content necessitates clear guidelines for citing websites and individual web pages. The Chicago author-date system requires specific information to ensure these digital sources are properly attributed and locatable.

General Website Entry

Example: National Geographic Society. 2023. "The Majestic Polar Bear." In *National Geographic*. Last modified September 15, 2023. Accessed October 26, 2023. <https://www.nationalgeographic.com/animals/mammals/p/polar-bear/>.

Web Pages without Dates

If a web page lacks a clear publication or modification date, it is important to state this. Use "n.d." (no date) for the publication date. However, the access date remains critical.

- Author Last Name, First Name (or Organization Name). n.d. "Title of Specific Web Page." In *Title of Website*. Accessed Month Day, Year. URL.

Citing Other Common Sources

Beyond books and journal articles, researchers often consult a variety of other source materials. The Chicago author-date bibliography system provides guidelines for these as well, ensuring consistency across your reference list.

Newspaper and Magazine Articles

Alphabetical Order
