## Understanding the Chicago Style Author-Date System

The Chicago Manual of Style (CMOS) offers two primary citation systems: notes-bibliography and author-date. The author-date system, as its name suggests, emphasizes conciseness by including the author's last name and the year of publication within the text. This method is particularly favored in the social sciences and sciences for its directness. ## Citing Books in Chicago Style (Author-Date)

## Citing Journal Articles in Chicago Style (Author-Date)

The reference list entry for a journal article is more detailed than for a book.

## Citing Websites and Online Resources in Chicago Style (Author-Date)

If no author is listed, use the organization or website name, and if no date is available, use "n.d." for no date.
