A URL, while useful, can become broken if the page is moved or deleted, making the DOI a more reliable method for ensuring long-term access to the cited material. For resources without a DOI, a stable URL is the next best option.

Citing Online Journals and Articles from Databases

One of the most common uses of digital databases in academic research is for accessing scholarly

journals. Citing articles found within these databases requires careful attention to detail to properly attribute the work and guide readers to the specific content within the database environment.

Structure for Journal Articles

Example:

National Aeronautics and Space Administration. 2023. "Mars Rover Mission Updates." NASA Science. Accessed March 15, 2024. <https://science.nasa.gov/mars-rover/updates>.

Distinguishing Between Website and Database

It's important to differentiate between a website that hosts content directly and a database that aggregates or indexes content from multiple sources. If you are accessing an article that was published in a journal, even if you found it via a database, you cite it as a journal article. If the content originates directly from the website itself (e.g., a blog post, a company report), then you cite it as a

web page.

Citing Digital Archival Materials

Archives are increasingly digitizing their collections, making primary source materials accessible online. Citing these digital facsimiles requires a format that reflects their archival origin and their digital accessibility.

Format for Digitized Archival Content

When citing a manuscript, letter, or other archival item that has been digitized and made available online, you will typically include information about the original collection and the digital repository:

Author Last Name, First Name. Year. "Title of Document or Description of Item." Date of Original Document. Collection Name, Box Number, Folder Number. Name of Archive or Repository. Accessed Month Day, Year. URL.

Example:

Lincoln, Abraham. 1863. "Gettysburg Address." January 1, 1863. Papers of Abraham Lincoln, Box 15, Folder 3. Abraham Lincoln Presidential Library and Museum. Accessed March 15, 2024.
<https://www.lincolncollection.org/documents/gettysburg-address>.

Note that the date of the original document is included before the description of the archival context. The date of access and the URL are essential for locating the digitized version.

When Only a Digital Version Exists

If the archival material exists only in a digitized format and was not originally a physical document, you would adapt the format to reflect its digital nature, potentially omitting original physical location details if they don't apply. However, most commonly, you are citing a digital surrogate of a physical item.
