Understanding the Chicago Author-Date System

The Chicago Manual of Style (CMOS) offers two primary citation systems: notes-bibliography and author-date. The author-date system is frequently employed in the social sciences and natural sciences due to its streamlined approach, allowing readers to quickly identify the source of information within the text and locate the full bibliographic details with ease. This system relies on parenthetical citations within the body of your paper, which include the author's last name and the year of publication or, in the case of unpublished material like interviews, the date the interview was conducted. These in-text citations correspond directly to entries in a reference list, also known as a bibliography, which appears at the end of your work.

The primary goal of any citation system, including Chicago author-date, is to provide clear attribution to the original source of information. This not only avoids plagiarism but also allows your readers to verify your research, explore your sources further, and understand the context of your arguments. For interviews, which often represent primary data or unique insights, accurate citation is particularly crucial for establishing the credibility of your findings and respecting the contributions of your interviewees.

Citing Interviews in the Reference List (Bibliography)

The reference list, or bibliography, is where you provide the full bibliographic details for every source cited in your paper. For interviews, the format of the entry will depend on whether the interview has been formally published, is available in an archive, or remains an unpublished personal communication. Regardless of the format, the goal is to provide enough information for a reader to locate or identify the specific interview.

Key Components of an Interview Citation

Interviewee as Author

For an unpublished interview you conducted, the format generally follows: Interviewee Last Name, First Name. Interview by Interviewer First Name Last Name. Date of interview. Type of interview (e.g., Personal interview, Phone interview, Email interview).

For example:

Smith, John. Interview by Jane Doe. May 15, 2023. Personal interview.

If the interview was published or is part of an archive, additional details about its location will be necessary.

Interviewer as Author

In some contexts, particularly when the interview itself is being analyzed as a piece of work, or if the interviewer has significantly shaped the content or presented it in a specific format, the interviewer might be considered the author. This is less common for basic citation of interview content but may arise when analyzing interview methodologies or published interview collections. The format would then prioritize the interviewer's name, followed by information about the interviewee.

Interview with No Specific Author Listed

If an interview is published in a collection or archive where no individual interviewer or interviewee is clearly designated as the primary author (e.g., oral histories focused on a specific event), the entry may begin with the title of the interview or the collection name, followed by relevant identifying information and the date. However, for personal interviews, it is almost always possible to identify at least the interviewee.

In-Text Citations for Interviews

In-text citations in the Chicago author-date system are brief parenthetical references that appear within the body of your text, immediately following the information you are attributing to the source. These citations direct your reader to the full entry in your reference list.

Citing an Interview in the Text

For an unpublished interview that you conducted, the in-text citation will typically include the interviewee's last name and the year the interview was conducted. If you have multiple interviews with the same person in the same year, you would add a letter (a, b, c) to the year to distinguish them, as assigned in your reference list.

For example, if you interviewed John Smith on May 15, 2023, and your reference list entry has him as "Smith, John," the in-text citation would be (Smith 2023). If you interviewed him again on June 10, 2023, and it was listed as (Smith 2023b), then you would use (Smith 2023b) for that second interview.

If the interview is published or archived, the citation will also include the author's last name and the year, following the same principles as any other published source in the author-date system.

Variations and Special Cases

The Chicago author-date system is flexible enough to accommodate various types of interviews, from those conducted over email to oral histories preserved in archives. Understanding these variations ensures accurate representation of your sources.

Archival Interviews

Interviews held in archival collections require specific information to help readers locate them. The citation should include the interviewee's name, the date of the interview, the name of the collection, the archive where it is housed, and any relevant box or item numbers.

For example:

Miller, Sarah. Interview by David Lee. August 20, 1998. Oral History Collection, Box 5, Item 12. University Archives, Chicago, IL.

The in-text citation would be (Miller 1998).

Published Interviews

When an interview has been formally published, either as a standalone work, part of a book, or in a journal or magazine, it is cited much like any other published source. The author (often the interviewer, or the interviewee if presented as their work) and the publication year are key.

For an interview published in a book:

Interviewer Last Name, First Name, interviewer. "Title of Interview" (if

applicable). By Interviewee First Name Last Name. In *Title of Book*, edited by Editor First Name Last Name, page numbers. Publisher, Year.

Example:

Gallo, Maria, interviewer. "A Conversation with Historians." By Robert Johnson. In *Modern Perspectives in History*, edited by Eleanor Vance, 112-135. University Press, 2022.

The in-text citation would be (Gallo 2022).

Email Interviews

Email interviews are treated as unpublished correspondence. The interviewee is the author, and the date is the date of the email.

Format:

Interviewee Last Name, First Name. Email to Interviewer First Name Last Name. Date of email.

Example:

Wilson, Emily. Email to Mark Brown. April 3, 2023.

The in-text citation would be (Wilson 2023).

Common Mistakes to Avoid

Researchers often make errors when citing interviews, particularly regarding the year of the interview versus the year of publication (if applicable) and the distinction between personal interviews and published ones. Ensuring consistency in your citation style is also crucial.

- **Confusing interview year with publication year:** Always use the date the interview was conducted for unpublished interviews. For published interviews, follow the publication details.
- **Inconsistent formatting:** Adhere strictly to the Chicago author-date format for all interview citations to maintain professionalism.
- **Omitting essential details:** Ensure you include enough information for a reader to identify and potentially locate the interview.
- **Incorrectly identifying the author:** Determine who is considered the primary author based on the context and presentation of the interview.
