if you are quoting a line from Shirley Jackson's "The Lottery," and the collection in which you found it was published in 1999, and the quote is on page 221, your citation would look like this: (Jackson 1999, 221). It is crucial that the year cited is the publication year of the specific edition of the collection or anthology you are using, not necessarily the original publication year of the short story itself.

If the author's name is mentioned in the sentence, you can omit it from the parenthetical citation, as long as the year is provided. For example, instead of saying "The story states that...", you could write, "According to Jackson, the story states that..." and then cite (1999, 221). This approach helps to integrate the citation more smoothly into your prose while still providing the necessary publication information. Always ensure the year and page number are accurate for the source material.

Paraphrasing and Summarizing

When you paraphrase or summarize a short story, the in-text citation still requires the author's last name and the year of publication. For example, if you are discussing a plot point from a short story by Flannery O'Connor, published in a 2015 collection, you might write: The protagonist grappled with her faith in a moment of crisis (O'Connor 2015). "The Snows of Kilimanjaro." In *The Complete Short Stories*, 305-318. New York: Scribner.

It is important to note that the year cited in the bibliography should be the publication year of the specific edition of the collection you used. If the collection has been reissued, and you are using a newer edition, use the year of that newer edition. The title of the collection should be italicized.

Short Stories in Anthologies

Citing a short story from an anthology involves providing details about both the story's author and the anthology's editor and publication information. The general format for an anthology entry is: AuthorLastName, FirstName. Year. "Title of Short Story." In Title of Anthology, edited by EditorFirstName EditorLastName, PageNumbers. Publisher.

For instance, if you are citing Ray Bradbury's "The Veldt" from an anthology titled *Science Fiction Classics*, edited by John Smith, published in 2018 by Penguin Books, and the story is on pages 55-70, the bibliography entry would appear as: Bradbury, Ray. 2018. "The Veldt." In *Science Fiction Classics*, edited by John Smith, 55-70. London: Penguin Books.

Ensure all details are accurate, including the editor's name and the page range where the short story can be found within the anthology. The title of the anthology is italicized, and the editor's name is listed as "edited by" followed by their full name.

Common Scenarios and Special Considerations

Navigating the Chicago style author-date system for short stories can present unique challenges, particularly when dealing with works published online, older stories, or those with multiple editions. Understanding these common scenarios will help you maintain accuracy and consistency in your citations.

When a short story is available online, you must adapt the citation to reflect its digital nature. This often involves including a URL or DOI (Digital Object Identifier) if available. The year of publication for online sources can be tricky; use the publication date of the

If accessed online: Accessed Month Day, Year. <https://doi.org/xxxx> or <https://www.example.com>.

For a short story found on a website or in an online collection without a DOI, the format might be: AuthorLastName, FirstName. Year. "Title of Short Story." Title of Website/Collection. Publisher (if different from website name). Accessed Month Day, Year. <https://www.example.com>. For example, if you are citing a short story by Alice Munro found on a literary website in 2023, and the story was originally published earlier, your entry might look like: Munro, Alice. 2023. "Dimensions." The New Yorker. Accessed October 26, 2023. <https://www.newyorker.com/magazine/2006/08/21/dimensions>.

Original Publication vs. Collection Publication Date

A common point of confusion is whether to cite the original publication date of a short story or the publication date of the collection in which you found it. The Chicago style author-date system mandates that you cite the publication date of the specific edition or collection you are using for your research. This ensures that your in-text citation and bibliography entry directly correspond to the source material your reader can access.

While the original publication date might be important for historical or literary analysis, it is not what appears in the author-date citation. However, recent editions suggest that for well-known publishers, the city may sometimes be omitted for brevity if it does not cause confusion. It is always safest to include it.
