Therefore, identifying the specific edition used is paramount to accurately representing the source material and allowing others to engage with the same version of the work.

Citing Books with Specific Editions

When citing a book that is not the first edition, it is essential to clearly indicate the edition number or description in both the in-text citation and the reference list entry. This practice ensures that readers are directed to the precise version of the text that you consulted.

In-Text Citations for Books with Specific Editions

The in-text citation for a book using the author-date system generally includes the author's last name, the year of publication, and often a page number. When a specific edition is used, the year of publication in the in-text citation usually refers to the year of that particular edition. It is crucial to be precise with the edition designation as provided by the publisher. If the publisher uses "Revised Edition," then "Rev. ed." is appropriate. If they use "Second Edition," then "2nd ed." is correct. Consistency in formatting this information across all your references is also key.

Citing Articles and Chapters from Edited Volumes (Specific Editions)

Citing contributions within larger edited works, especially when those works are in specific editions, requires careful attention to detail within the Chicago author-date framework. This often involves referencing a chapter within a book that itself might be in a particular edition.

In-Text Citations for Articles/Chapters from Edited Volumes

In the author-date system, the in-text citation for an article or chapter within an edited volume typically includes the author of the specific contribution, the year of publication of the edited volume, and the relevant page number. Reference List Entries for Articles/Chapters from Edited Volumes

- AuthorLastName, AuthorFirstName. Year. "Title of Article or Chapter." In *Title of Edited Volume*, edited by EditorFirstName LastName, Edition Number or Description, page range. City of Publication: Publisher.

For instance, if you are citing a chapter by Emily Carter in the third edition of a book edited by David Lee, published in 2021:

Carter, Emily. 2021. "The Impact of Technology on Education." In *Educational Innovations*, edited by David Lee, 3rd ed., 45-67. Chicago: University of Chicago Press.

It is vital to include the edition information for the edited volume if it is not the first edition. This ensures that the reader can locate the exact version of the collection you consulted. The page range for the specific chapter is also crucial for easy retrieval.

Citing Online Resources and Digital Editions

The Chicago author-date system extends to online resources and digital editions, but with adaptations to account for the dynamic nature of digital content and the presence of distinct digital versions of print works. When referencing online articles or e-books that have specific digital editions or are accessed from a particular online platform, the citation must reflect this.

In-Text Citations for Online Resources and Digital Editions

For online resources that follow an author-date convention, the in-text citation will typically include the author's last name and the year of publication or last revision. If a specific digital edition is relevant, the year associated with that edition is used. For instance, (Garcia 2022) would be used if citing a resource published online in 2022.

When citing e-books that mirror print editions, the year of the e-book edition is generally used in the in-text citation. If page numbers are available and stable (as they often are in e-books), they should also be included: (Garcia 2022, 112).

Reference List Entries for Online Resources and Digital Editions

The format for online resources in the author-date system requires the inclusion of a URL and the date of access. For digital editions of books that correspond to print editions, the edition information is treated similarly to print books, but with the addition of digital access details.

For online articles:

For e-books with specific editions:

- AuthorLastName, AuthorFirstName. Year. *Title of E-book*. Edition Number or Description. City of Publication: Publisher. Accessed Month Day, Year. URL.

Example:

Chen, Li. 2021. *Understanding Digital Marketing*. 2nd ed. Boston: Digital Publishing House. Accessed October 26, 2023. <https://www.digitalpublishinghouse.com/ebooks/chen2021>.

It's important to check if the online resource explicitly states a publication or revision date. If not, and if there's an access date, that may serve as a proxy, but it's less ideal for the author-date system which relies on a publication year. If a specific edition of an online journal article is relevant, that edition information should be included if provided by the journal.

Variations and Special Cases in Chicago Style Author-Date Citations

While the core principles of Chicago style author-date citation remain consistent, certain situations necessitate adjustments to ensure accuracy and clarity, particularly when dealing with multiple works

by the same author, anonymous works, or revised editions of older texts.

Multiple Works by the Same Author

When citing multiple works by the same author published in the same year, the Chicago Manual of Style requires that each work be appended with a lowercase letter (a, b, c, etc.) in both the in-text citation and the reference list entry. This distinction is crucial for differentiating between these publications.

- In-text example: (Smith 2020a, 55) and (Smith 2020b, 102).
- Reference list example:
 - Smith, John. 2020a. *The History of Ideas*. New York: Academic Press.
 - Smith, John. 2020b. *Further Explorations in Philosophy*. London: University Press.

Anonymous Works

If a work has no author listed, the Chicago author-date system generally uses the title of the work in place of the author's name in both the in-text citation and the reference list. If the title is long, an abbreviated version may be used, but this should be consistent throughout the text.

- In-text example: (*Guide to Modern Art* 2018, 30).
- Reference list example:
 - *Guide to Modern Art*. 2018. Paris: Art Books International.

Revised Editions of Older Texts

When citing a newer edition of a classic or older work, it is good practice to acknowledge the original publication date alongside the edition year, especially if the original publication date is historically significant. This can be done in the reference list entry.

- Plato. 2015. *The Republic*. Translated by Benjamin Jowett. 3rd ed. (Original work published 380 BCE). New York: Oxford University Press.

In the in-text citation, the year of the edition being used is typically cited: (Plato 2015, 150).
